Supervisors and Staff,

The department handled 1182 calls for the month of June 2023. Listing calls by criteria: 14 Thefts, 6 Drug Offenses, 12 DUI's, 9 Simple Assaults, 3 Sexual Assaults, 8 Harassments, and 21 all other offenses. Additionally, officers responded to and investigated 1109 other calls for service including 19 Domestic related incidents and 16 traffic accidents. They issued 123 traffic citations, 138 warnings, issued 13 non-traffic citations and made 30 misdemeanor/felony criminal arrests.

Extended times waiting for beds at the hospitals, the need to restock supplies and human/computer error recording times are not accounted in the 'Total Time'.

Newberry Township Monthly Manager's Report Board of Supervisors meeting Tuesday July 25, 2023

Township Business:

- ➤ The first 4500 Chevy truck has been delivered and is in service with Public Works. The two remaining trucks have been delivered to the upfit vendor. The rebate voucher submission is under review by DEP for all three trucks totaling \$168,000.
- > Phase II for Terry Dolan Park rehab for the pavilion and playground equipment grant was resubmitted by our new grant writer on May 30.
- ➤ Received notification on May 18 that we were successful in our application process for RACP. Grant amount is \$2,000,000. More documentation will be required as we move through the construction phase. Awaiting a State consultant to be assigned.
- > Construction of the MESB continues. Check out the progress pictures on our website.
- > Ongoing procurement (MESB) process for furniture, sign, and propane tank.
- Public Assistance Application to FEMA/PEMA for damages and costs associated with Hurricane IDA continues. All necessary documents were uploaded previously but PEMA has extended it again to give them more time to review.
- ➤ We continue to work on the reporting and application processes for the grants that were awarded in March. Multiple items for the Police Department are on the agenda that are 100% reimbursed by those grants.

> Sewer

- Potential Sale of Sewer process, the bids for the sewer were rejected at the June 18 workshop meeting. This closes out the bid process. No further charges/fees will be forthcoming from PFM.
- > Continuing with water shutoffs and sewer plugging for residents who are delinquent for over one year.
- > The sewer extension for Old Trail Rd. Bid was approved by the Board and executed. Work tentatively scheduled to begin the first week of August.

Newberry Township Board of Supervisors Treasurer's Report July 27, 2023

- Final documentation was sent to PEMA for reimbursement for Hurricane Ida expense reimbursement.
- Presentation of the 2022 financial statements will be done at this meeting.
- The annual re-certification of our Safety Committee was approved by the State. There will be a credit on the worker's compensation insurance.
- The Township is investigating accepting credit cards at the window for Township transactions. Sewer credit card processing will remain on-line only.
