RESOLUTION NO. 2023-27

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF NEWBERRY PROVIDING FOR SUPPLEMENTAL APPROPRIATIONS FOR THE 2023 BUDGET

WHEREAS, Newberry Township (“Township”) is a second class township duly organized and existing under the Second Class Township Code; and

WHEREAS, the Board of Supervisors of the Township adopted a budget for the calendar year 2023 on December 13, 2022; and

WHEREAS, the Second Class Township Code Article XXXII, Section 3202(e) authorizes the Supervisors to, by Resolution, make supplemental appropriations for any lawful purpose from any funds on hand or estimated to be received within the fiscal year not otherwise appropriated; and

WHEREAS, the Township desires to replace the bridge on Pleasant Drive (“Pleasant Drive Bridge Project”) and applied for a grant to conduct the work. The total cost of the Pleasant Drive Bridge replacement is \$474,582 and the Township received a grant in the amount of \$332,207 for the Pleasant Drive Bridge Project.

WHEREAS, the Township desires to complete the work for the Pleasant Drive Bridge Project and use \$142,375 from the General Fund in conjunction with the \$332,207 grant received.

WHEREAS, the Township has the funds available to make the supplemental expenditures related to the Pleasant Drive Bridge Project in its General Fund.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Newberry Township, to make the following supplemental appropriations for the 2023 budget from the General Fund of the Township:


SECTION 1. An appropriation in the amount of \$474,582 for the Pleasant Drive Bridge Project, which would be paid with \$332,207 in funds received from a grant and \$142,375 from the General Fund. .

SECTION 2. This Resolution shall be effective immediately.


