Student hereby holds the space, its officers, owners, agents, and employees harmless from all claims which may be brought against them by student or on student's behalf for any such injuries or claims. Should student(s) permanently move their residence more than 25 miles from an affiliated area, payment on this agreement will be suspended upon payment of an appropriate cancellation fee of \$50.00 and legitimate verification of the move. Students agree to follow our rules as promulgated from time to time. Violation of these rules may be the cause for suspension or cancellation of contract. Any holder of this consumer credit contract is subject to all claims and defenses which the buyer/student could assert against Ayumi's Oasis Self Defense & Mixed Martial Arts as a result of this contact. Recovery by the buyer/student shall not exceed the total amount paid by the buyer/ student to us pursuant to this contract. You The buyer may cancel this agreement by midnight of our third business day after the date of this agreement, and such cancellation must be in writing to the school. Default and late payment

Cancellation

Membership plans can be canceled at any time; however, all cancellation requests must be submitted via [email](#) and received thirty (30) days prior to your credit/debit card processing date. Membership cancellations initiated by the client before ½ of the contract duration (6 months) will be charged full price up to the 6-month mark. Cancellations after the 6-month mark will be charged 50% of the remaining contract duration. All plans and monthly memberships require a minimum of 30 days written notice prior to next billing date to assure cancellation of automatic payments. Cancellation requests submitted within the 30-day billing cycle will result in a final payment drawn from your account on your established auto draft date. It is your responsibility to provide written notice 30 days in advance of your next billing date. There will be no refund issued once a payment has been charged to your credit card. All monthly recurring term plans require 30 days written notification prior to your next bill date and will incur an early cancellation fee equal to one month membership for that plan.
