The undersigned person(s) has registered to participate in dog training and/or boarding to include any other dog related "activity" at 23335 462nd Ave, Wentworth SD 57075 or other off sight training locations or test sites. All activities, which the undersigned person(s) and dog(s) attend, are subject to this release.

1. I hereby certify that I am the owner(s) of _____, that will participate in the activity, training or testing.

2. I understand that other dogs and people will attend the activity, training or testing and that during the course of training, my dog will come into direct contact with other participating dogs and people on the property at which we are located or attending.

3. I hereby certify that the named dog has been fully vaccinated for Bordetella and rabies and will provide proof of vaccinations at time of training or boarding. In view of the fact that my dog will come into direct contact with other dogs on the property, I am aware that my dog may be exposed to those infectious diseases described above; however, since signing this release form certifies that my dog is fully vaccinated against those diseases, I alone assume responsibility for any such exposure.

4. I am aware that given the sometimes-unpredictable nature of dogs, an interaction could take place between dogs at the activity, which may result in injury to my dog, to myself, to other dogs, to other people or damage to personal property in which I will be financial responsible for all accrued costs that may accumulate from such scenarios. I am also aware that the sport of “Dog Agility” & “Dog Training/Testing” has inherent risk factors, which may cause injury to my dog, to myself, to other dogs or to other people. However, in order for my dog to participate in the activity I alone assume responsibility for any such injury and costs that can accrue.

5. Act of Nature/Act of God- in the instance that one of these events occurs Marzolf X Kennel, LLC and all associated members will be held harmless for any damages to include but not limited to injury or death of a dog. Marzolf X Kennel, LLC will hold no liability or financial responsibility.

6. I understand that if my dog is not spayed or neutered that Marzolf X Kennel, LLC will do its due diligence to monitor dogs for heat cycles and separate male and female dogs from interacting but cannot guarantee or be held liable if an accidental breeding takes place. If we identify a female in season we will notify the owner and they have the option of taking the female home until her heat cycle has come to an end. If an accidental breeding takes place the owners of the female will be responsible for any and all expenses occurred and Marzolf X Kennel, LLC will hold no liability or financial responsibility.

7. I understand that dog(s) displaying aggressive behavior, as determined by Marzolf X Kennel, LLC, will be barred from participation in any and all activities and no refunds will be given. If a person’s animal inflicts injury to another animal, the owner of the instigative dog will be held liable and responsible for all medical damages incurred by the owners.

8. Marzolf X Kennel, LLC, their independent contractors or assistants, I hereby waive and release any actions, causes of actions, damages, rights, claims or lawsuits which I may have for any reason, including but not limited to: (a) any and all personal injury, property damage and property loss, which I may sustain arising out of any interaction between dogs and/or people participating in the activity or residing on the property, and (b) any and all injury, illness or diseases sustained by my dog(s) arising out of or stemming from its participation in the activity.

I have read and understand this release form and I will honor and abide by the terms and conditions set forth above.

Boarding Fees

Nightly Boarding for 1st dog is \$35 per night; second dog is \$30 per night (plus 4.2% South Dakota state sales tax). All dog's dropped off prior to 3pm or picked up after 11am will be charged an additional night for each dog. Boarding fees include food. Dogs staying more than 7 days will receive a \$5 a day discount.

Media Release

I, the undersigned, do hereby consent and agree that Marzolf X Kennel, LLC and its employees, or agents have the right to take photographs, videotape, or digital recordings of our dog and all family members while training and to use these in any and all media, now or hereafter known, and exclusively for the purpose of Marzolf X Kennel, LLC advertising and social Media. I further consent that my first name and identity may be revealed therein or by descriptive text or commentary. I do hereby release to Marzolf X Kennel, LLC, its agents, and employees all rights to exhibit this work in print and electronic form publicly. I waive any rights, claims, or interest I may have to control the use of my first name or likeness in whatever media used.

If an animal is not picked up when scheduled for training and or boarding there will be a \$50 per day fee for care and boarding of the dog. After 30 days of refusal to pick up a dog the owner waives all legal rights of ownership in exchange for forgiveness of unpaid debt and the animal becomes the sole property of Marzolf X Kennel, LLC to do with what is scene fit.

I understand that there will be no financial or other reimbursement for recording myself, either for transmission or playback.

I represent that I am at least 18 years of age, have read and understand the foregoing statement, and am competent to execute this agreement.

Owners will receive an official send home video the final week of scheduled training. This video will include how to handle your animal from basic obedience to field training. It will have a voice over with the video to ensure that all commands and handling is outlined. At pickup basic obedience will be reviewed along with any additional questions answered at this time.

No field work will be performed in person due to insurance and liability risks having personnel in the field and around live fire. We are also unable to manage the weather risks that can be associated with performing these operations.
