### Section III – Hold Harmless

You and/or your Organization hereby indemnify, defend and agree to hold harmless Pasco Horsemens Association and its Officers, Board Members and Members against all demands, claims, damages to persons or property losses and liabilities, including injuries resulting from an accident or other incident. Under Florida Law an equine activity sponsor or an equine professional is not liable for an injury to, or the death of a participant in equine activities.

### Section IV – Liability Insurance

You and/or your Organization must have, during the entire term of this agreement, liability insurance coverage. Pasco Horsemens Association shall be named as an additional insured under each insurance policy. Pasco Horsemens Association shall be provided with certificates

of liability insurance no later than one week prior to your event. No event will be conducted until proof of insurance is provided. Pasco Horsemens Association reserves the right to cancel all reservations for failure to comply with insurance provisions.

Section V – Deposits

A \$250 non-refundable deposit in the form of cash, check or money order must be received upon execution of this contract to retain your event dates.

Section VI – Final Payment

Final Payment, in the form of cash, check or money order shall be made with seven (7) days of event. Event may be cancelled if final payment is not received on time.
