**ORDER GRANTING
SIXTH QUARTERLY APPLICATION
FOR PAYMENT OF FEES AND
REIMBURSEMENT OF EXPENSES
OF RECEIVER AND RECEIVER’S
COUNSEL GREENBERG TRAURIG
FOR PERIOD OCTOBER 1, 2023
THROUGH DECEMBER 31, 2023**

19 The Court having reviewed the Receiver’s Sixth Quarterly Application for Payment of Fees
20 and Reimbursement of Expenses of Receiver and Receiver’s Counsel Greenberg Traurig, LLP
21 (“Application”) for the period of October 1, 2023 through December 31, 2023 (“Application
22 Period”), and having found that notice was proper and that cause exists to approve the Application,
23 orders as follows:

- 24 1. The Sixth Application is granted in its entirety;
25 2. American Fiduciary Services (“AFS”) fees and expenses incurred during the
26 Application Period, in the respective amounts of \$102,500.00 and \$1,625.55 are approved;

1 3. The Receiver is authorized to pay AFS on an interim basis, 80% of its approved
2 fees incurred during the Application Period, in the amount of \$82,000.00, and 100% of its
3 approved expenses incurred during the Application Period, in the amount of \$1,625.55, from the
4 funds of the Receivership Estate;


5 4. Greenberg Traurig's fees incurred during the Application Period, in the amount of
6 \$14,253.57, is approved;

7 5. The Receiver is authorized to pay Greenberg Traurig on an interim basis, 80% of
8 its approved fees incurred during the Application Period, in the amount of \$11,402.85, from the
9 funds of the Receivership Estate;

10 6. Baker Tilly's fees and expenses incurred during the Application Period, in the
11 respective amounts of \$469.50 and \$53.40 are approved and the Receiver is authorized to pay the
12 same in full from the funds of the Receivership Estate.

13 7. The Court further clarifies that payment to Allen Matkins for fees incurred prior to
14 the Appointment Order, in the amount of \$8,981.45 was approved as part of the Third Fee
15 Application.
