



THIS FORM MUST BE SIGNED BY THE LEGAL PARENT OR GUARDIAN Minors under the age of 18 may participate at any event hosted by the Oasis Online Arcade, including the tournaments and any related events (e.g., meals, practices, registration, etc.) with the signed consent of the minor's parent or legal guardian ("Parent"). If a participant is under 18 years of age, he/she is considered a minor and must submit this consent form, signed by a parent or legal guardian. If the Parent is not available to accompany the minor to a Oasis Online Arcade event, someone over 18 from the must be appointed responsible by the Parent. Consent to Attendance: The events are video game tournaments where an entry fee may be charged and cash and other prizes may be awarded to certain winners. Parent further understands that the events may feature video game competitions featuring one or more video games that have an ESRB Rating of "M", and that this rating indicates that ESRB, a recognized industry adopted ratings agency, has deemed content of the video games unsuitable for children under 17 years of age. Release: By his/her signature, Parent gives his/her permission to allow the above named Minor to attend any and all event activities without restriction or limitation, including but not limited to viewing video games with an ESRB rating of "M", and Minor and Parent hereby release and hold harmless the Oasis Online Arcade, its affiliates, subsidiaries, suppliers, related companies, advertising and promotion agencies or partners, and any of their respective officers, directors, employees, representatives and agents, from any and all liability that may arise from the Parent's decision to allow Minor to attend the events. Assumption of Responsibility: Parent assumes all responsibility and liability for any and all damage and injury suffered by or caused by Minor while at the events or any areas surrounding the events. Rights: In connection with Minor's appearance at and participation in the events, the Parent, on behalf of Minor, give the Oasis Online Arcade, the other event sponsors and their respective licensees, designees and assigns (individually and collectively, "Producer"), the right to film, photograph and record Minor's name, nickname, pseudonym, persona, picture, biographical material, voice and/or likeness and to use the same in any manner or media in connection with the events, and the advertising and promotion thereof or of Producer including, without limitation, in all forms of television, video, radio, and other advertisements, promotions and publicity for Producer, the events and other motion pictures (collectively "Advertisements"); to broadcast, reproduce, distribute and exhibit such photographs and/or recordings, the events and/or the Advertisements, in any manner whatsoever, by any and all means, media, devices, processes and technology now or hereafter known or devised anywhere in the universe at any time in perpetuity; to give Minor's name and information. About Minor on the events and in the Advertisements; and to edit, modify, adapt, make derivative works from, copyright and otherwise exploit the pictures and recordings as Producer elects. Minor and Parent, on behalf of Minor, hereby acknowledge that Minor's appearance at the events shall not constitute a performance and that Minor shall not be entitled to any compensation for such appearance, nor to any guild or union payments for use or reuse of such appearance. Consent to Clips, Photos, Stills: Producer has Parent's consent to incorporate any photographs, audio-only or audiovisual recordings in which Minor appears (including, without limitation, news, television and/or motion picture footage) in the events and/or Advertisements for use as outlined above as well as for historical documentation and/or archival purposes, including without limitation, on Producer's website (e.g., showing Minor's

participation in the events); and Minor and Parent, on behalf of Minor, hereby waive any right to any additional compensation, including but not limited to, any excerpt and/or refuse fees and/or residual payments. Prohibited Drugs: Parent, on behalf of Minor, represent and warrant that Minor will not take any illegal drugs, abuse any prescription or over the counter drugs, partake or possess alcohol, nor take any performance enhancing drugs prohibited by the World Anti-Doping Agency (WADA). Anyone using illegal drugs will be removed permanently from the events and local authorities will be contacted. Anyone under the age of 18 who is found to be intoxicated or in the possession of alcohol will be removed from the events and local authorities will be contacted. Release: Minor and Parent, on behalf of Minor, understand that all of the foregoing is a material inducement for Producer to proceed with the events and Advertisements, and that Producer may rely on this Release in proceeding with the events and Advertisements. Minor and Parent, on behalf of Minor, hereby release the Releases and the advertisers, broadcasters and distributors of the events, (a) from any and all claims for damage or personal injury arising from or relating to Minor's participation in the events, and (b) from all liability and obligation to Minor of any and all nature whatsoever arising out of or in connection with the exercise of the rights granted herein including, without limitation, from any liability for violation of rights of privacy, publicity, defamation, emotional distress or any similar right. Minor and Parent, on behalf of Minor, hereby indemnify the Releases from and against all claims, actions, losses, damages, judgments and liabilities resulting from any breach or alleged breach of this agreement and/or any actions or omissions by Minor while participating in the events. In no event shall Minor or Parent have, and Minor and Parent hereby irrevocably waive, any right to sue the Releases or to seek or obtain injunctive or other equitable relief in connection with the events, the Advertisements or any other productions, or the production, distribution, exhibition or other exploitation, or the advertising, promoting or publicizing of the events. This is the entire agreement and, subsequent to execution, cannot be modified without written consent.
