Present: Mayor Stronks, Councilwoman Hansen, Councilman Pincock, Councilman Atchley, and Councilwoman Harrigfeld.

Mayor Stronks called meeting to order at 3:05 PM.

1. UNFINISHED / OLD BUSINESS:

Each speaker will be allowed a maximum of 5 minutes unless repeat testimony is requested by the Mayor/Council.

A. Garbage Request for Proposals – City Clerk Stegelmeier

The Council went over the RFP and gave City Clerk Stegelmeier some changes to make. The
changes include some typos and a five year contract with protections for the City. Councilwoman
Hansen used the question 'If it's not broken, why fix it?' to express her opinion that PSI has done a
good job, worked well with the office and with the customers. She is not sure there is a reason to
go out to bid. Councilwoman Harrigfeld expressed her concern that the costs may raise and that
with the water rate raising, customers will again be hit with a raise in rates. Councilman Pincock
expressed his opinion that a local person is interested in starting this business and would need this
kind of opportunity to do so. Councilman Atchley expressed his opinion that it would be nice to
work with a local owner, but he is not sure that the local owner has much of a chance in making his
bid competitive. The Council discussed the need for an extension so that the bidding process can
be completed.

Councilman Pincock made a motion that the City's garbage service go out for bid, that City Clerk Stegelmeier incorporate the changes put forth and that a one year extension be signed by the Mayor. Councilwoman Harrigfeld seconded the motion. The motion carried.

2. NEW BUSINESS/PETITIONS:

Each speaker will be allowed a maximum of 5 minutes unless repeat testimony is requested by the Mayor/Council.

A. City Insurance – City Clerk Stegelmeier, Mayor Stronks
Mayor Stronks explained that he may be losing his insurance and would like to ask the Council to
approve letting City Officials pay for their costs, but allow them to be included in the City's health
insurance group. It would apply to all elected officials.

Councilman Pincock made a motion to allow elected officials join the City's group health plan at their own cost. Councilman Atchley seconded the motion. The motion passed unanimously.

3. ADJOURNMENT

Councilman Pincock made a motion to adjourn. Councilwoman Hansen seconded the motion. The motion passed unanimously.
