### **CALL TO ORDER & WELCOME**

In Attendance: Teddy Stronks, Teresa Hansen, Becky Harrigfeld, Tadd Atchley and Brett Pincock.

Also in attendance: City Clerk Stegelmeier, Britney Stegelmeier and Christina Hatch.

Mayor Stronks opened the meeting at 6:56 pm.

#### 1. OLD BUSINESS:

- A. Brief Council Discussion on Sign Code Concerns
  - Mayor Stronks has consulted with City Attorney Lookabaugh on whether he should still preside at this meeting because his son owns one of the businesses that has been complaining about the sign ordinance. City Attorney Lookabauch told him that it is important for him to tell the council that he will be unbiased in the discussion. Mayor Stronks said that he could be unbiased. He went on to say that there have been several businesses that have complained about the sign ordinance being hostile to their business. Councilman Pincock said that the issue is troubling. He said that the P&Z Commission has worked hard on cutting down the ordinance and now the ordinance is mainly definitions. He does not feel that there is anything that is out of line or too strict in the ordinance. City Attorney Lookabaugh said that the concern is that the complaints are ongoing and that businesses have said that they feel that the ordinance is impinging on their business. Councilwoman Harrigfeld explained that she was on the P&Z Commission when the commission spent hours and hours going through the ordinance and cutting it down. She went on to wonder in that people are complaining/calling but had not attended any – not one – P&Z meeting, let alone the P&Z or Council public hearings. The P&Z had asked people specifically what they wanted but no one attended anything. Councilwoman Hansen explained that she had been thinking about this issue all week. A rule is a rule until the rule is changed. Maybe there is a way to present that rule that would work better for businesses. Councilman Atchley expressed his opinion that the sign ordinance is too large surrounding cities are using 2 to 3 page documents to do the same thing. Councilwoman Hansen that she thinks that there is a lot of misinformation. Councilwoman Harrigfeld explained that she thought the P& Z would be willing to work on it again but that this time, the Council needs to read it and give guidance to the commission so that they are aware of what they should be going over. Councilwoman Hansen explained that just complaining doesn't help. Everyone needs to read it and give good suggestions for change – not just throw out something that has been worked on several times. Councilman Pincock thinks that the thought is that we are rednecks and just don't want to be told what to do. Mayor Stronks explained that businesses say it is not business friendly. It comes back again to whether they have read it or if it is just hearsay. City Attorney Lookabaugh wondered if changing the way we communicate the rules to incoming businesses would help - such as a sort of checklist when they inquire about business licenses. She then went on to say that it seems that they have exhausted the sign ordinance conversation and should think about it after more discussion at the next meeting.
