Wipes and Wastewater

BUT they are not biodegradable.

As the wipes arrive at the City's wastewater treatment facility they often get caught in the large fans (or aerators) which are used to help process the sewage. This can stop the aerators and sometimes burn up (ruin) the motors.

Stopping the aeration also affects the ability of the facility to process (or digest) the sewage in order to clean it for use on the city's land application site.

These pictures were taken at the city's wastewater treatment facility on November 4th, 2021. The oper-

ators take a boat to get out to the aerators to try to pry the wipes out of the motors. The top photo shows the wipes wrapped on the blades of an aerator.

It is difficult to work on the aerators. The city's public works department employees spend many hours trying to keep the facility working.

Please remember to only flush toilet paper and human waste. Anything else can cause problems with the sewer system.

Remember this photo from late last year? There are still wipes ending up at the wastewater facility. These wipes are causing serious problems.

There are now products that are sold to replace toilet paper. These products usually have the term 'flushable' on the packaging. Many customers also think Sanitizing wipes and baby wipes are flushable. Of course, these products will flush down your toilet

City Budget Hearing

It is that time again!!

A public hearing, pursuant to Idaho Code 50-1002 for consideration of the proposed budget for the fiscal year that begins October 1, 2022 and ends September 30, 2023, will be heard in the City Council Chambers, City Hall, 714 Main, Ashton, Idaho, on Wednesday, August 24, 2022, at 6:00 p.m.

Written or oral comments about the proposed budget are welcome. Copies of the proposed FY2023 City of Ashton Budget (in detail) are available at City Hall from

8:00.m. to 4:00 p.m. on weekdays. City building is closed for lunch from 12:00 p.m. to 1:00 p.m.

The budget includes information about the services and facilities proposed for FY2023 and the associated revenues projected within the budget.

City Hall is accessible to persons with disabilities.

Any person with disabilities desiring accommodations for the public hearing, please contact the City office at (208) 652-3987 at least 48 hours prior to the public hearing.

Do You Need A Permit??



Did you know that all fences and buildings require at least a Class I Zoning Permit? **Ashton Municipal Code 17.16A.010** give the details of what requires a permit. A single-family home, a single commercial building (even a grain bin), a fence, a garage, a storage shed are all things that require a permit. You can get the application on our website or at the city office.

A Class I Zoning permit is easy.

The fee is a flat \$25 and you just need to provide some basic details and a sketch of where you are putting your structure with respect to the property lines

and other structures. In the Low-Density Residential Zoning District, fences can be placed right on the property line. Structures must be 15 feet away from the property line near city property and 6 feet away from the property line at the alley or adjacent lots. All structures on the property must be 5 feet apart.

Any construction over 200 sq-ft must have a Building Permit which is separate from a Class I Zoning permit.

The city's Building Inspector reviews the detailed plans to determine compliance with the International Building Code, which has been adopted by the city and the state, and approves this permit application. The Inspector will not begin his review until the Planning & Zoning Administrator has approved the Class I zoning permit. The fees for a

Building Permit depend upon the structure.

Ashton Municipal Code provides for fines to be levied if anyone is in violation of the city's development code. This means if you start building anything, even a fence, without a permit, you can expect a visit from a Police Officer with a stop work order until you get the proper permit.

The City's Planning & Zoning Administrator Sara Bowersox or Deputy Clerk Jan Warnke can help you with your project.
