Meeting Minutes

Chairman Hamilton called the meeting to order at 4:05 PM. The first order of business of the meeting was to approve meeting minutes from August 29 and September 19, 2012. There were no additions or changes to either set of minutes. Stacy Wynn moved to approve the minutes of August 29th, MaryLou seconded the motion, the motion passed. Teddy Stronks moves to accept the minutes of September 19, 2012, Stacy Wynn seconded the motion, the motion passed and the minutes were approved.

Payment of Invoices

Chairman Hamilton presented invoices from Elam and Burke for work conducted on both the legal issues involving Ashton Memorial and work being done to coordinate the drafting of eligibility reports for the amended and new urban renewal areas.
