2016 RESULTS OF THE ONLINE GOVERNMENTAL CONSENSUS VOTE

The Final Action on code change proposals considered at the Public Comment Hearing (PCH) in the 2016 Group B Cycle were determined solely by the results of the OGCV because a hand/standing vote count was taken at the PCH for all of these code changes in accordance with Sections 7.5.8.7 and 7.5.8.8 of CP28 Code Development. Therefore, in accordance with CP28 Section 10.1, these code changes do not have a corresponding PCH vote tally and the votes of the PCH will not be combined with the corresponding OGCV ballot. In accordance with published OGCV procedures, this required a minimum of 20 OGCV votes to be cast for each code change proposal in order for the OGCV to be considered a successful voting measure. If the OGCV vote total is less than 20 for an individual proposal, the Final Action for that proposal is the action taken at the Public Comment Hearing (see Note 4).

In accordance with Section 10.1 of CP 28, the validation committee has certified the OGCV voting results and the ICC Board has verified a valid voting process. The following are the results of the OGCV, published in accordance with Section 10.4 of CP 28.

Final Action notes:

1. The Final Action for each code change is noted in **bold** in the second column and reflects the OGCV Results also noted in **bold**, except as indicated by note 3.
2. The “required majority” is in accordance with Section 8.1 of CP 28.
3. For those code changes where the required majority was not achieved (e.g. ADM2-16 Part IV), the Final Action on the code change is D in accordance with Section 10.3 of CP 28.
4. In all cases, the required minimum of 20 OGCV votes to be cast in order for the OGCV to be a successful voting measure was exceeded.
5. As stated in the posted 2016 Group B Public Comment Hearing Agenda, ADM94-16 was dealt with procedurally by dividing the code change proposal into a multiple part code change proposal, with each referenced standard receiving a public comment being dealt with as a separate part in conjunction with the submitted public comment.
