You will learn cattle stockmanship, proper handling, and tips and tricks. Cattle will be fresh from the cattle ranch, and never worked by dogs. You will learn how to safely and quickly dog gentle cattle. And dogs will be given the opportunity to learn to control cattle and move them around. Handlers will learn how to sort and move cattle around as well. You will learn where to stand to support your dog, to build confidence and work as a team. Working cattle is a team sport!

**Prerequisites:** Dogs must be well-started at least on sheep. This is not a camp for beginners or dogs less than 1 year old. Dogs must have at least a stock call off and a reliable on stock down/stop to work cattle safely.

**About Jacqueline:** I have been in the farming/ranching lifestyle for most of my life. I got into Aussies when I was 14 years old and have had a working bred Aussie (at least one) since then. I was the first junior handler to get a WTCH on a dog WAY back then. I currently live on a small ranch in Central Texas and my dogs work my livestock daily. We have cattle, sheep and goats and lots of birds.

I have been training working stockdogs professionally for seven years. I have handled and trained hundreds of dogs to this point and I have students with all types of working bred dogs. I am fortunate to have some amazing working dogs in my life. My current main dog, Copper, won ASCA cattle finals in 2022 and has become a YouTube star, showing off his amazing talents and quirky personality.

As a former educator, I excel at presenting topics in a clear and direct manner. I have a passion for teaching dogs how to control livestock and to use their problem-solving skills. My desire is to show participants how to develop their dogs, so the instinct is forward, and the brain is freed up to solve problems.
