Obedience Group Exercises: Novice group exercises will occur after the individual Novice exercises.

Cancellation Policy: No refund requests will be issued after the closing date April 29,

2024. No refunds will be issued for absent, disqualified, or excused dogs. No entry fee will be refunded if the show cannot be opened or completed for reasons of riots, civil disturbances, fire, Acts of God, or public emergency. Upon verification of a veterinarian or show committee member a refund will be given to bitches in season.

Awards: 1st-4th place and green qualifying or a "x" qualifying ribbon when applicable. Rosettes will be awarded to HIT, HIT Other Breed, HIT Junior, and High Combined.

Other Information:

This is an ASCA sanctioned event and will be governed by the rules of the Australian Shepherd Club of America.

The show will be held indoors with a ring sized 40 'x 50'. Limited ring-side crating will be available. No crating, food, and dog treats within 10 feet of the ring. No setup allowed before 8am on April 6th. All setups need to be removed at the end of the trial April 7th. Building hours will be 8am-6pm both days or until the trial ends.

No entry shall be accepted from a dog or handler disqualified from all ASCA programs, or a person not in good standing with ASCA.

The facility, show-giving club, the Show Chairman, their agents, officers and/or committee assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers or to any of their dogs or property and further assumes no responsibility for injury to spectators. All dogs must be on leash or confined to a crate/x-pen at all times except while in the ring during competition. Exhibitors are responsible for the behavior of their dogs or guests. Any Exhibitor whose dog or guests create an unnecessary disturbance or engage in an unsafe or disruptive behavior may, at the direction of the trial committee be asked to leave.
