2. The permission extended cannot be transferred or assigned to any other person WITHOUT PRIOR CONSENT OF THE BOARD OF DIRECTORS.

3. Lou Lou, LLC, or its designer has the right to approve in advance all improvements, and if the Artist fails to obtain such approval, to cancel and rescind this license.

4. Artist must maintain the Cottage and the grounds immediately surrounding it in good order and repair, and upon failure to do so permission may be with- drawn and the license cancelled and rescinded.

5. The artist is required to maintain the hours of operation specified.

Full Season we will be open: Wednesday to Friday 10 a.m.-5 p.m.; Saturday 8:30 a.m. -5:00 p.m.; and Sundays and Holidays 11 a.m. to 4 p.m., except during severe, inclement weather which would place the safety of Artist and his or her work in jeopardy. Failure to be open to the public during this period could result in cancellation and rescission of this license.

7. This is a license only that is revocable by the LICENSOR at will and as otherwise specified herein and does not create expressly or by implication any property, prescriptive, adverse possession, or other rights to the cottage or surrounding area.

8. Artist may only display and sell artwork as approved during the jury process. The selling of food, and products bought or obtained for resale is expressly prohibited, unless licensed by a Health Department. This is only allowed during special events.
