The NCCFFF Fall Fly Fishing Festival was held on October 7th & 8th at the Nugget Hotel in Sparks NV. The Festival offered fly tying demonstrations, casting clinics, vendor booths, breakout sessions, and the Learning Center.

The Festival's highlight was the Saturday night Banquet, where Felix Smith was presented the NCCFFF Lifetime Achievement Award. Felix is a fisheries biologist, recently retired after 34 years in the U.S. Fish and Wildlife Service. Felix was one of the biologists on the team that found the first deformed birds in 1983 at Kesterson National Wildlife Refuge. He risked his career to make sure that this environmental catastrophe was made public and wasn't kept hidden. Felix has also written and given testimony about the preser-

## **Conservation Update: the Delta**

Three current pressing issues in Conservation are focused on the Delta of Central California: 1) the **Delta Plan**, which is out for comment on its draft EIR; 2) the **Bay Delta Conservation Plan (BDCP)**, which continues to move forward in the face of significant conservation group push back; and 3) the proposed new regulations on Striped Bass coming from DFG as a result of the lawsuit settlement discussions between Plaintiffs (Citizens for a Sustainable Delta) and the Defendants (DFG).



**Delta Plan** - This is the product of about 2 years of work by the the Delta Stewardship Council, a group created in 2010 by the California Legislature. Over the past 18 months, Mark Rockwell has participated in the Environmental Water Caucus (EWC), and thus represented the interests of NCCFFF. The most recent draft EIR document (2,400 pages) is now under review by members of EWC, along with other interested groups. This is the document that mandates the co-equal goals of water system reliability and recovering the Delta ecosystem, and reduced reliance on the Delta.

The plan has many restoration projects included to enhance aquatic systems and support fish, and has many related directions and guidance for "covered activities" - those that the Council can over-see and mandate. Some of these are helpful for our interests, e.g., SWQCB flow evaluations for both through-Delta and major tributary rivers. These are to be completed by 2014 and 2016 respectively. That said, there is no mandate to use them other than the SWQCB will have the information available when permitting the BDCP and associated water delivery infrastructure. Additionally, the draft plan lists and pushes for increased water conservation, urban water use efficiency, reclamation and ground water management. It's too early to discuss content in the EIR draft as it is long and our review is in process.

**Bay Delta Conservation Plan** - The BDCP has from the beginning been a plan requested by the water contractors (DWR and BOR are the applicants), and as such has been

very focused on increased delivery of water from the Delta. They have tried to make it look like the co-equal goals are the focus, but in the end more water is what they are after, as well as legal certainty on these deliveries.

This is a 50 year Habitat Conservation Plan (HCP) under the ESA, and a Natural Communities Conservation Plan (NCCP) under the CESA, and as such has the mandate to both protect listed species, and recover them too. Hence, it has the goal of recovering species (mainly fish) while taking more of the water they need; a real problem for both sides of the issue.

A recent MOA, agreed to between the water contractors and the federal and state agencies, has put the CVP contractor needs as the first priority, along with letting them manage or participate in the process of developing the EIR/ EIS. Push back from conservation groups has caused much difficulty for the state and federal agencies, and resulted in a 15 day comment period. NCCFFF helped develop a comments letter from the EWC to the agencies; it was signed by more than 240 groups.

I have been working with other conservation groups to coordinate efforts and speak with a single voice against a host of inequities that are in the current version of the plan. This has resulted in the agencies holding a series of meetings with the NGO community to identify and find solutions to our concerns. From my perspective, the agencies continue lip service to our issues, and are simply having meetings as a way of saying they are working on our issues. The next few months will be telling about what the agencies are willing to do. Stay tuned.

In the end, BDCP will be incorporated into the Delta Plan. The Delta Plan is set up with the "hole" for BDCP which includes water operations and the new diversion facility on the Sacramento River. Ironically, both the 15,000 cfs facility on the Sacramento River and increases in diversions are listed as "Conservation Measures" in the BDCP. The irony here is that they not only cause more stress on listed species - not a contribution to conservation - but allow the water contractors to list the costs of these as their mitigation (compensation) for project operations. Hence, the only money they will likely put in is that which pays for the diversion facility. The other costs - restoration, adaptive management, land purchases, science team, etc. will be borne by the taxpayer. Thus, citizens will pay increased water rates caused by the water agencies bearing the cost of the new facility, and will pay the costs associated with the water bond on the ballot this year. It is a double punch for taxpayers.

**Striped Bass Regulatory Change** - Citizens for a Sustainable Delta (a group of water exporters) brought a lawsuit against DFG for not having a take permit for striped bass predation on listed Delta fish. Judge Wanger, following preliminary testimony, stated the case should not be settled without a full court hearing on the merits of the case. As an option, he offered to consider a settlement between the parties if they agreed to bring one to him. That was the choice taken, and DFG and the Plaintiffs came forward with what we now see. The issues:

•Change minimum size to 12"

•Change bag limit from 2 to 6, except in special zones (Clifton Court Forebay) where the limit will be 20.

•Change the possession limit from 2 to 12, except in the special zones where it is 40. In the special zone area there is no size limit.

•Allow harvest of striped bass in the Pajaro, Carmel and Salinas Rivers when the fishery would otherwise be closed.

Currently, many groups are working to oppose this change, and letters can be sent using the Water4Fish website, http://water4fish.org/striper/. The F&G Commission has planned meetings to take input, discuss and decide on this change. NCCFFF will have a comment letter prepared in advance of these meetings. NCCFFF is also developing a post card campaign so anglers and citizens can voice their opposition to the Commission. We will have ample opportunity to make our voices heard in 2012. Striped bass as we know them are totally at risk here. If we want to continue to have a striped bass fishery in the years ahead, we have to defeat this change.

### 2012 Hall of Fame Awardee: Hal Janssen

Hal Janssen is a nationally known writer, artist, lecturer and video personality. He has been fishing for over 50 years for nearly every species of fresh and salt water fish. Old timers from the Golden Gate Casting Club adopted him as a child, setting him up with a shooting head and teaching him to cast. Hal is one of the very few in the world with naturally polarized eyes which allow him to correctly analyze stream conditions, and take fish repeatedly when others are unsuccessful. Growing up in the 50's Hal was an active member of the "Rivers of a Lost Coast Greats Group," and a consummate stillwater authority. Hal's self-confidence and fiery enthusiasm seem to guide him in everything he does.

Hal and Scientific Anglers developed S/A's wet tip fly line. He helped develop Sunset Line Company's fly lines, the first tapered lead core line, and the invention of the density compensated uniform sink line. Hal came up with clear fly lines and was part of changing Amnesia from solid to fluorescent colors. He created fly display boxes, tools, shirts, and more. Hal also designed a signature line of hooks with Partridge-U.K., and consulted with a number of companies on rod design. Over 70 Janssen fly patterns are distributed worldwide. Hal has a series of three videotapes, a book, and is about to launch a new stillwater book. He and his wife Jane founded the Hal Janssen Company in 1979, the first exclusively fly fishing equipment distributor; they retired in 2007.

As a fine artist, Hal Janssen has illustrated all the fly drawings and paintings for Anglers' Calendar for over 20 years, and has illustrated many magazine articles. When Hal gets involved he usually gets "Best of Show," i.e., his fish carvings. He calls them "Living Wood" because of their unique life-like realism. In his spare time, Hal restores classic cars and has achieved professional pin striper status.

Hal has written over 25 articles for leading fly fishing magazines. He has contributed to 21 books both as an artist and an author. Hal gained broad recognition as an instructor for his stillwater fly fishing seminars and schools, and has entertained thousands in fly club presentations. He helped found the Diablo Valley Fly Fishers Club and is a fisheries consultant to conservation groups.

When they are not at Lake Almanor, Hal Janssen lives in Forest Ranch, California, with his wife Jane. He is an exceptional individual who has made significant contributions to this area and to our sport. More than that, you can expect to be bowled over when he shares the evening with us.

This venue will be a great location for disabled and able bodied veterans to enjoy a day of fly fishing. The disabled can enjoy the pond area while those wishing a chance at wild trout can work upstream in moving water with their volunteer guide.

## **Smith River Report**

Sonar fish counts on the Smith totaled approximately 18,000 chinook salmon during the 2010 season between October 15 and December 31. This year 15,000 have been counted between October 1 and November 25. Information from Zack Larson of the Smith River Advisory Council, indicates that the run this year looks similar to that from 2010. We keep track because NCCFFF has worked on Smith River issues since the early 1970's and is concerned about the heavy angler use received by this designated Salmon Stronghold river.

Snaggers had a good early salmon season this year on the lower Smith. Unfortunately, it took DFG's local warden a while to understand that busting a few folks is necessary to sometimes make a point. As a result of this unsportsmanlike behavior, NCCFFF and others are proposing regulation changes that would restrict angling methods to catchand-release single barbless hooks only, when flows are below 400 cfs. Other protective proposals will be presented when the Commission meets in April in Arcata. This report will be updated on the NCCFFF website in Spring 2012.

### **Fish Returning to Battle Creek**

Bureau of Reclamation Press Release

The Bureau of Reclamation and its partners in the Battle Creek Salmon and Steelhead Restoration Project have announced that larger numbers of threatened Chinook salmon have returned to spawn upstream in newly restored habitat on North Fork Battle Creek, near Manton, California.

The U.S. Fish and Wildlife Service (FWS) has been performing fish monitoring in Battle Creek for many years. This fall, over four times the number of spring-run Chinook salmon redds were seen further upstream in North Fork Battle Creek than in previous years. In the past 10 years, only about 7 percent of the redds were upstream of the Wildcat Diversion Dam. This year, 33 percent of the redds are located upstream of the former dam site (the dam was removed in 2010).

It is the improved passage upstream into the restored area, where stream conditions are better for nesting and survival, that is helping the populations. This signifies that the project goal of increasing populations of anadromous fish is already underway, while project construction continues.

Battle Creek, a tributary to the Sacramento River, is being restored through the Battle Creek Salmon and Steelhead Restoration Project. The project is a proactive, cooperative effort to increase threatened and endangered Chinook salmon and Central Valley steelhead populations by restoring approximately 42 miles of habitat in Battle Creek and an additional 6 miles of habitat in its tributaries. Restoration is being accomplished primarily through the removal of five diversion dams, placement of screens and ladders on three other diversion dams, and increasing instream flows.

Project construction began in 2009, and in August 2010, Wildcat Diversion Dam was removed on North Fork Battle Creek, restoring approximately 15 miles of stream habitat.

Also on the North Fork, substantial fish screen and ladder construction has occurred upstream and is anticipated to be completed in 2012 or 2013. On South Fork Battle Creek, construction of a powerhouse bypass and tailrace connector to Coleman Canal has been proceeding and is anticipated to be completed late-2012. The remainder of the project is anticipated to be completed in 2015.

<u>Editor's Note:</u> In spite of this meritorious and costly (\$128 million) restoration effort, Battle Creek salmonids remain threatened. Almost the entire upper Battle Creek watershed is a patchwork of barren clearcut areas (see photo on page 8) resulting in the usual downstream water quality issues of turbidity and sediment buildup. A complete article on this Battle Creek problem will appear in the March 2012 River Mouth.
