REQUIREMENTS FOR HELPING CHILDREN PARTICIPATE GRANTS

The Village Commission of New Minas wishes to support children and youth who otherwise would not have the opportunity to participate in sport, recreation, arts and leisure activities, regardless of their socio-economic situation.

To this end, funding is made available to assist children and youth to participate in Villagerun and other programs. This funding is made possible through the generosity of local sponsors, and by the Village Commission of New Minas' operating funds.

The criteria for eligibility for the "Helping Children Participate" Grant is as follows:

- The Village Commission of New Minas will carry out the selection process for the "Helping Children Participate" grant program in a fair manner.
- Application Form must be completed in its entirety.
- ➤ Grants will not exceed \$300 per year per applicant, or 2 weeks' registration at Day Camp, whichever is the lesser.
- > Preference will be given to youth who are first-time applicants to this fund.
