#### **New Business:**

Beautification

The Commission discussed the roundabout coming into New Minas and the need to have that space more appealing as it is a main entrance into New Minas.

# Milne Subdivision

The Commission discussed an uptick in theft from vehicles especially in Milne Subdivision. James Redmond advised the residents should continue to report to the RCMP and the Commission will reach out to the RCMP Community Liaison to do a presentation on crime rates in New Minas in the near future.

## **Correspondence:**

John Ansara advised the Commission of a phone call he received from New Minas Resident Cathy McDow. Ms. McDow is concerned about a lack of Police presence in New Minas especially around Commercial Street as she has noticed a lot of erratic driving. The Commission believes that the Police presence is there, especially with ghost cars. The Commission will be contacting the Community Liaison to present.

#### **Public Discussion Period:**

Maynard Stevens commended the Commission and Staff on their plan to recognize business' in New Minas. Mr. Stevens inquired about the status of Canada Day and Celebration Days Events. John Ansara advised that these are being planned as normal. Mr. Stevens also noted that he has observed an increased number of traffic infractions.
