TO APPOINT TOWNSHIP "CODE ENFORCEMENT OFFICER"

WHEREAS the Board of Trustees has the statutory authority to approve and adopt Resolutions to control and regulate certain activities and or conditions in the Township for the health, safety and welfare of the Township and its residents; and

WHEREAS the Township desires to establish the position of "CODE ENFORCEMENT OFFICER" for the purpose of enforcement of such Resolutions within the Township in addition to and separate from the positions of Township Police Officer and Zoning Inspector; now, therefore.

BE IT RESOLVED THAT, the Board of Trustees does hereby establish the position of "CODE ENFORCEMENT OFFICER;" and

BE IT FURTHER RESOLVED THAT, the Board of Trustees does hereby authorize the "Code Enforcement Officer" to take any and all legal action to enforce Township Resolutions, exclusive of the State of Ohio Criminal Code, and the Township Zoning Resolution; and

BE IT FURTHER RESOLVED THAT, the Code Enforcement Officer shall be under the direction of the Board of Trustees, and shall report directly to the Board of Trustees or its designee; and

BE IT FURTHER RESOLVED THAT, the Code Enforcement Officer position shall be a part-time position scheduled to work no more that ten (10) hours per calendar work week; and

BE IT FURTHER RESOLVED THAT, compensation of the position of Code Enforcement Officer shall be on the basis as an hour rate for hours worked at the rate of \$ _____ per hour, payable in accordance with the Township's payroll schedule; and

BE IT FURTHER RESOLVED THAT, the Board does hereby appoint Mr. Paul Freer to the position of Township Code Enforcement Officer, as at at-will part-time employee.


