Until the 7th century, Lent actually began on the Sunday 6 weeks prior to Easter. The extra 4 days were added later, to unite us to the 40 days of fasting by Jesus Christ in the desert.

Originally, the 1st day of Lent was the day public penitents began their penance. The penitents were sprinkled with ashes, clothed in sackcloth, and required to remain separated from the community until Maundy Thursday, the Thursday before Easter. Between the 8th and 10th centuries, the practice ceased, and was replaced with what we know today; the entire congregation receives ashes out of devotion. Reflection and Penance. The ashes are made from the blessed palms used in Palm Sunday celebration of the previous year. The ashes are christened with Holy Water and scented with incense.

"They fasted that day, put on sackcloth and sprinkled **ashes** on their heads, and rent their clothes." Maccabees 3:47



Standing Rules - Please read the revised rules approved in January's meeting:

- 1. Court Christ the Good Shepherd #2731 meets at 7 pm for regular meetings on the 1st Thursday of the month.
- 2. No meetings will be held in the months of July and August.
- 3. We will hold a short business meeting for the month of December and then have a social event.
- 4. Membership dues will be \$25 per year and collected in February or at the time of membership.
- 5. The Court funds will be held at Wells Fargo Bank of Texas.
- 6. The Regent may spend up to \$50 per month without the vote of the Court. She must provide receipt(s) for reimbursement.
- 7. Cards may be sent to the members for their birthdays and anniversaries.
- 8. A mass card may be sent for serious illness or death of a Catholic Daughter or an immediate family member.
- 9. The Court may donate up to \$25 to each new court established in the Archdiocese of Galveston-Houston.
- 10. The Court will present a Mass card to each parish priest and deacon on their ordination anniversary and to transitional deacons assigned to Christ the Good Shepherd upon their ordination.
- 11. The Court will waive the reading of the minutes from the previous meeting providing there are no corrections. A hard copy report will be available at the meetings. The minutes will be sent to all members by email or attachment to the newsletter.
- 12. State CDA convention expenses may be subsidized as follows: Based on the amount approved in the annual budget, State convention expenses will be reimbursed by equally dividing the amount approved in the annual budget between two (2) delegates and two (2) alternates attending the convention. The convention amount in the budget will also take into consideration the monies for registration, travel expense, meal cost and lodging.
- 13. The Board members are allowed to spend up to \$50 each without getting Court approval and by presenting receipts to the Court for payment.
- 14. The Party Planning Committee can spend up to \$50 without getting Court approval and by presenting receipts to the Court for payment.
- 15. If there is a conflict with a meeting date and a Holy Day or a church sponsored event, the Board can reschedule the meeting to the first available date that the church has a room opening.

From State Regent, Rosie Stockwell: The 3rd Biennial Pray & Play Project is right around the corner and we are counting on all of you to help us make this project a huge success!




This is a State Project coordinated by the Missions of Mercy (MOM) State Chairman, Cathy Bittner and State Co-Chairman, Benji Pardee.





Old Business

Sunshine Report: Linda Zakrzewski has resigned; the court is looking for a chairperson and volunteers.

Budget Report – Veronica Arnold went over the sample budget. Changes were made. A Motion was made by Karen Doolittle to approve the Budget as Amended. Mary Jane Brewster seconded the motion. It was voted on and Approved as amended. (see attached amended budget).

A. February 1st – CDA Anniversary Mass – 7:00pm Mass followed by small gift exchange for our birthday celebration (less than \$5.00) and finger food appetizers/dessert party. Guylaine Belley will set up. She suggested instead of bringing a small gift for the gift exchange to bring \$5 to donate to the Court as a fundraiser. Members agreed to the \$5 fundraiser for the Court instead of a gift exchange.

B. February 4th at 9:00 am Mass Vice Regent, Charlotte Prieve will pick up the traveling crucifix and pray for vocation. Any members that want to attend are more than welcome to come to Mass.

New Business

- A. 57th Biennial National Convention Gloria Riley asked if anyone from our Court was planning on going to the National Convention. It will be July 17-22 in Sioux Fall, ND. Gloria Riley will need to fill out forms for anyone that wants to attend. No one will be attending this event.
- B. Nomination Committee We will need a nomination committee set up. Their job will be to approach potential candidates to run for an officer position. We will need 3-5 members. The nominees will be presented to the Court in April. Elections are in May and New Officers are installed at the June meeting. - D. - G. Fundraising We need a chairperson to research fundraiser for the Court. We will have to have approval from the Financial Committee in order to do a fundraiser on the church grounds. We might be able to ask the Knights of Columbus if they would help us with a pancake breakfast. We could also ask the Knights of Columbus if they would let us set up a table at the Fish Fries to sell Mass Cards.
- H. Framing of the Charter Sheryl Andrews said it would cost about \$137.91 to have the Charter framed with a glass fronting. A Motion was made to approve the amount of \$137.91 for the framing of the Charter by Mary Jane Brewster. Sheryl Bihler-Lopez seconded the Motion. It was voted and Approved.

Priscilla Hargraves has the T-shirts ready for pickup. You can see her after the meeting. It is being looked into as to whether or not we can wear our T-shirts as a group to the Anniversary Mass.

Priscilla Hargraves talked about the Circle of Love forms. They need to be in her hands by February 1st (can be turned in at that meeting). They have to be completed as a Court and submitted by March

1. If you will not be a the February meeting you can scan or mail them to her or give them to her in church. The time period is from March 1, 2017 to February 28, 2018.

Priscilla Hargraves also asked if you have not filled out the supplemental forms (the one with birthday, anniversary dates, etc) please do so and give back to Gloria Riley.
