Please ensure you read and abide by all By-Laws and Policies as they refer to pets. In addition, your co-operation in maintaining the following rules are greatly appreciated.

- 1) Photograph of each pet must be provided at time of application
- 2) All dogs must be licensed within the by-laws of the Regional Municipality of Wood Buffalo.
- 3) Defecation on common property must be cleaned up immediately.
- 4) Dogs must be on a leash no longer than six (6) feet long at all times.
- 5) Excessive barking will be treated as a noise complaint.
- 6) Cats must be confined inside the unit and not allowed to wander at large.
- 7) Pets are not to be tied to patios/balconies for long periods of time/when owners are not home.
- 8) Pet waste/litter must be tied in a plastic bag and placed directly in the garbage bin.
- 9) Owners will be responsible for ANY/ALL damages caused by their pets.
- 10) Must not interfere with other occupant's enjoyment of the property
- 11) Approval is specific to these particular pets, any new pets must obtain additional approval
- 11) PETS WILL ONLY BE ALLOWED AT THE DISCRETION OF THE BOARD OF DIRECTORS.
