Frank Seney indicated the scope of work consists of furnishing all labor, equipment, and materials and performing all work required to rehabilitate the Sign Shop Building located at Central Maintenance Yard, Milepost 28 along the Atlantic City Expressway in Hammonton Town, New Jersey. The rehabilitation to the building is detailed within the project manual and contract plans.

#### IV Notice to Bidders

Frank Seney discussed the following:

1. A mandatory Bid Security is required to accompany all bid submissions at 10% of the Total Bid Price but not to exceed \$20,000.00.

- 2. A Consent of Surety is mandatory from all bidders and is to be completed on Bid Express. All bidders must file one.
- 3. Bids will only be received via electronic format through BidExpress.com. Electronic bids are due **Tuesday**, **January 24**, **2022** @ **1:00 PM**, and will be read aloud by the Purchasing Department at the **SJTA Administration Building located at Farley Service Plaza**. Any portion of the project that falls under the following work: **Plumbing, HVACR, Electrical, and Structural Steel/Ornamental Iron** shall only be performed by the entity (Bidder or Subcontractor) prequalified to perform the specified work and is to be declared on the Subcontractor Declaration on Bid Express.

#### 5. PRE-QUALIFICATION: General Contractor Requirements ITB-10

The bidder shall be pre-qualified under at least one of the following NJDPMC Class Code(s) at the time of submission:

- NJDPMC Trade Code C008 -General Construction
- NJDPMC Trade Code C009 -General Construction/ Alterations & Additions

#### The bidder shall be pre-qualified at the time of submission.

6. The Bid Form is to be completed on Bid Express.

The Authority, according to law, reserves the right to reject any or all bids and also to waive any minor informality or non-material exceptions in any bid or bids so received. There is no guarantee that the Authority will award this bid in any form and in submitting a bid the bidder agrees to this understanding.

- 7. Contract Insurance Requirements, *GC-83 thru GC-88*. Specific requirements are indicated. Bidders should include this in your bid. After checking with your insurance provider, include the insurance cost in your bid and sign the Insurance Acknowledgement Form which shall be completed on Bid Express.
- 8. Prevailing Wage Act Compliance Declaration is to be completed on Bid Express. Contractor is responsible for checking with the NJ Department of Labor website. Please be sure to check the current rates before bidding. Also, if you are awarded the project, per the Department of Labor, the rates that are in effect on the date of the award are the rates that must be used for the project.

### V Questions

ISSUANCE OF ADDENDA: Responses to all questions of substantive nature will be answered in the form of an addendum. The SJTA shall be the sole judge of the question viability. Any informal explanation, clarification, or interpretation will not bind SJTA, oral or written, by whoever made, that is not incorporated into an addendum.

Notice of Addenda will be issued through Bid Express. It is the sole responsibility of the Bidder to be knowledgeable of all addenda related to this procurement. The Bidder must complete the "Acknowledgement of Receipt of Changes To Bid Document" form, which is included in this solicitation as a required document. Failure to acknowledge receipt of all addenda may render a bid as non-responsive.

A bidder's failure to request a clarification, interpretation, correction or amendment will preclude such bidder from, thereafter, claiming any ambiguity, inconsistency or error.

Failure to acknowledge each addendum on the Acknowledgement of Receipt of Addenda is cause for disqualification of the bid. The form shall be completed on Bid Express.

#### VI Award and Notice to Proceed

Frank Seney discussed the following:

- 1. Board approval is anticipated to be on February 15, 2023.
- 2. Governor's Veto Period will occur after the award and runs approximately 15 business days from receipt of the Board Meeting minutes.
- 3. Estimated Notice to Proceed will be after the veto period around mid to late March 2023.
- 4. Standard payment application and requirements will be provided at the preconstruction meeting. The 25<sup>th</sup> of each month is the cutoff for payment requests; all estimates are to be received by SJTA on the 25<sup>th</sup> of the month. Certified Payrolls are required with Payment applications.

#### **VII** General Conditions

1. TIME TO COMPLETE is indicated on Page ITB-10. The Contractor shall commence the work required by the Contract Documents within <a href="seven (7">seven (7)</a> calendar days after the date of the notice to proceed. The Contractor shall complete all work required by the Contract Documents within the number of calendar days noted below from and including the date of the written notice to proceed unless the period of completion is extended otherwise pursuant to the Contract Documents:

#### One Hundred Twenty (120) calendar days.

The Work Hours for this project shall be: Monday through Friday, 7:00 am to 3:30 pm, excluding any major holidays unless otherwise directed by the Engineer.

- 2. Liquidated Damages may be assessed at \$1,000.00 per day for each calendar day that the Contractor shall be in default in completing the work to be done under the contract as referenced on page ITB-10.
- 3. There are no free tolls. Contractors are to pay all tolls.

- 4. Contractor will be required to submit a project schedule in Primavera. Microsoft Project of other SJTA approved format.
- 5. Bidders are to refer to the Wage Rates link provided in Appendix 1 of the Project Specifications.
- 6. Contractor will be required to submit a maintenance bond at the end of the project for 100% of the final contract price for two years.
- 7. An addendum will be issued following this meeting that includes the minutes from the Pre-Bid meeting, the attendance sheet and any answers to questions posed at the meeting, if applicable.
- 8. All bidders are hereby advised, the South Jersey Transportation Authority does not release information regarding the project costs and estimates. Therefore, any and all information from any third-party entity such as online bid sourcing companies should be considered invalid. Project information is available to Bidders on the Authority's website at <a href="https://www.sjta.com">www.sjta.com</a> under "Bids & Contracts."

#### VIII SJTA Purchasing

#### IX Question and Answer Period

Frank Seney indicated the South Jersey Transportation Authority received two (2) questions from Levy Construction Company, Inc. These questions are as follows with answers provided.

- 1. 1Q: The drawings do not call for insulation at the foundations. Please confirm that no insulation is required. If insulation is required, please provide a detail.
  - 1A: There is no insulation required for the concrete foundations.
- 2. 2Q: The plans call for (3) 4" thick HVAC pads. Please confirm this is all that is required. Are these pads SOG?
  - 2A: The plans call for five (5) 4" thick concrete pads that shall be slabs on grade. They are for support of condensing units located on the exterior perimeter of the building. There are three (3) new units and two (2) existing units that require concrete pads as located on sheet no. M-2.1. The width and length of the pad for the new units shall be per manufacturer requirements for the unit size and verification of the existing unit size by the contractor for the existing units.

The following question was asked at the pre-bid meeting with the corresponding answer:

- 3. 3Q: Have the plans been approved by DCA plan review
  - 3A: Yes, stamped NJDCA approved plans have been received from the NJDCA.
