### **Tax Services**

EVERY TAX RETURN IS DIFFERENT! The tax laws are always changing. Your tax return may vary from year to year as your situation and the tax laws change. For that reason, final pricing is always subject to a client's unique situation and the complexity of their return.

We've adopted the "charge by form" method of billing tax return preparation fees. This method is upfront but imperfect. When we take on the task of preparing a tax return, we take into consideration the time it takes to prepare each form and sometimes the "charge by form" may overstate or understate the price based on actual time spent. In these cases, we will apply a discount or add fees to the final invoice. The goal is to invoice our clients in a fair and transparent way.

If you have been with us over the past few years, we appreciate your business and look forward to continuing to provide you with top quality services. You will see an increase of about 10% in tax preparation fees. We've had to make this tough decision to keep with rising software costs.

To ensure a timely filing, we ask that you provide all documents and information a minimum of 15 business days before the tax filing due date. We cannot promise your return will be completed and filed on time if you miss the cut-off. However, we will consider rush arrangements on a case-by-case basis for a minimum fee of \$250.

Starting January 1, 2023, we will require a deposit of \$75 for individual tax returns and \$100 for business tax returns that are dropped off. This fee is non-refundable and will be invoiced at the time the engagement letter is executed. This fee will be applied to the total of services provided and you will be invoiced for the remaining balance prior to receiving your return for review.

We will also require that you pay your invoice in full before we review your taxes. Therefore, when your taxes are ready for review, you will also receive an invoice for the remaining balance. If you have any questions about fees, please let us know.
