Position Summary

Families and individuals can access pre-license or licensed therapists through Family Links at home or in their communities. There is assistance available for resolving various issues, such as trauma recovery, family relationships, and reunification, and these services are available to young children, teens, and adults.

The therapist (or counselor from a related field) will provide clinical services to clients across the lifespan to address presenting problems stemming from trauma exposure and other challenges impacting human behavior. Therapists will assess, treat, and document interventions and progress toward goals on behalf of the client, the court, and insurance coverage. Therapists can work in the office, community, or family home to conduct treatment depending on the client's needs and the specifications of the case.

Position Responsibilities

- Provide assessment, therapy, skills development, case management services, safety planning, and recovery planning to children and adults referred by DCS or via Medicaid.
- Attend team meetings, court, and provider meetings
- Advocate for clients' best interests
- Educate providers and families regarding youth services/needs and obtain essential documentation
- Attend court and DCS/Probation as well as team meetings for clients
- Meet agency standards for service delivery by completing contact notes, monthly reports, progress notes, required assessments
- Adhere to DCS Service Standards and Medicaid
