RESOLUTION 2020-1

RESOLUTION ESTABLISHING CONTRACT FOR LEGAL SERVICES

WHEREAS, the City of Roscoe by and through its duly elected council members hereinafter referred to as "City of Roscoe" deems it necessary to contract with a licensed attorney and/or law firm to provide legal services to the City of Roscoe.

WHEREAS, SDCL 9-14-23 provides that, "[t]he governing body of any municipal corporation may contract for legal services or employ an attorney under such terms and conditions as the governing body shall deem proper. Any contract for legal services with an attorney shall be made by ordinance or resolution. Such contract shall set forth the compensation to be paid and the specific services to be rendered."

WHEREAS, the City of Roscoe has decided to enter into a contract for a City Attorney for legal services at \$230.00 per hour.

NOW, THEREFORE, BE IT RESOLVED, that the City of Roscoe hereby contracts with the law firm of Bantz, Gosch & Cremer, L.L.C., to provide legal services to the City of Roscoe from January 1, 2020, to December 31, 2020.

Bauman moved and Holscher seconded to approve signing a contract for 2020 with Joel Johnson, d.b.a Code Enforcement Specialists. Johnson bought out Mike Olson's code enforcement business, and is taking over the Cities in which Olson was working with. Five ayes and one nay by Hinz. Motion carried.

8:00 pm – This being the time for a Hearing for the applied Special 1-day event liquor license by the Roscoe Volunteer Fire Department for their Firemen's Ball on January 18, 2020. No one appeared to protest the license. Rohrbach moved and Holscher seconded to approve the Special Event License for the hours starting 12:00 pm January 18, 2020 to 2:00 am, January 19, 2020. All aye. Motion carried.

All positions on the City Council are open for election. Petitions can be started to be circulated on January 31st.

FO Bauman advised the Council on the lowered amount of the remaining budget money to the Fire Department. With insurance rates going up, the council may need to look into adjusting the money that is budgeted each year for the department.

Salaries for the City Council and employees as of January 1, 2020, are as follows: Mayor (Leland Treichel) – base pay of \$200 per month; regular, special, and equalization meetings - \$100 each.

Alderpersons (Dee Bauman, Mike Faw, Dale Hettick, Paul Hinz, Austin Holscher, & Darwin Rohrbach) - \$100 per meeting for regular, special, and equalization meetings. If the Mayor is gone for the meeting, the presiding officer receives \$10 extra for the meeting.

Full time Maintenance (James Fonder) - \$23.42 per hour. Also, that the City shall pay for full single Health Insurance Premium.

Finance Officer (Nicole Bauman) - \$19.11 per hour.

Part-time Maintenance (position open) - \$13.39 per hour.

The next regular meeting is Monday, February 3, 2020, @ 7:30 pm.

Hinz moved and Hettick seconded to adjourn. Motion carried.
