City Council Proceedings July 6, 2020 7:30 P.M.

The Roscoe City Council met in regular session in the City Office with Mayor Treichel presiding. Members present were Hettick, Faw, Bauman, Holscher, and Rohrbach. Absent: Lehr.

Rohrbach moved and Bauman seconded to approve the agenda. All aye. Motion carried

Hettick moved and Faw seconded to approve the minutes of the June 1, 2020, meeting as read. All aye. Motion carried.

Bauman moved and Rohrbach seconded to approve the payment of the following bills. All aye. Motion carried.

Jim Fonder was not at the meeting but left a message for the council about the lights for the ballfield. New lights will cost \$3000.00. Holscher moved and Rohrbach seconded to approve the purchase of the lights. All aye. Motion carried.

Alderwoman Bauman had been asked about what is considered the storm shelters in town. While Roscoe does not have true storm shelters, the restrooms at the park and the ballfield are built to be a safe space during a storm, as they are built with concrete bricks and no windows.

The Council discussed the park building, as there needs to be a choice made for siding, roofing, and interior color. Council decided on the khaki color siding to match the concession stand building at the ballfield. A matching/coordinating steel color will be picked for the roof.

Alderman Hettick discussed with the council his concerns on our power lines with MDU. There have been some sparking issues in spots, bare wires, and weak transformers. We will look into what we need to do in order to try to get them to correct these issues.

Faw moved and Bauman seconded to approve the appraisal of \$5000.00 for the 1985 Ford Pumper fire truck that was surplused. The Roscoe Volunteer Fire Department will work to try to sell the truck to a governmental entity (another fire department or fire district). If there is no sale, the truck will be sold at auction in Bowdle through Ulmer Auction. All aye. Motion carried.

The Council reviewed the latest code enforcement report. They had some concerns that some properties are being missed that should be given a notice. There are also some other issues that the council discussed that are being handled with Roscoe's insurance company.

FO Bauman discussed with the Council the rough draft that was put together for the 2021 budget. Besides the water/sewer project, there were no plans for any other large projects for next year. There may be some equipment upgrades, but that has not been agreed upon.

Bauman moved and Holscher seconded to approve the first reading of Ordinance #377: Ordinance to amend City Ordinance 3-1-15, after a change from last month. All aye, absent Lehr. Motion carried.

Bauman moved and Hettick seconded to adjourn. Motion carried.
