If dues have not been paid in full by January 1, 2024, the studio will run your card on file for the balance due.
- 2. <u>Volunteer Hours</u>: All families are required to donate 2 hours of volunteer time to the Booster Club. Each month there will be a variety of volunteer opportunities to choose from. If you are not able to fulfill the volunteer requirement, you can make a one-time donation to Boosters for \$50.
