ARTICLE I

The exact name of the corporation is:

GOLDFISH POND ASSOCIATION INC

ARTICLE II

The purpose of the corporation is to engage in the following business activities:

THE PURPOSE OF THE GOLDFISH POND ASSOCIATION INC IS TO PROMOTE THE GOLDFISH POND AND PARK IN LYNN, MA THROUGH BEAUTIFICATION, EDUCATION, RECREATION, A ND NEIGHBORLY RELATIONSHIPS. SAID CORPORATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE AND EDUCATIONAL PURPOSES UNDER SECTION 501(3)(C) IN THE INTERNAL R EVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE. NOT WITHSTANDING ANY OTHER PROVISION OF THESE ARTICLES, THE ASSOCIATION SHALL N OT CARRY ON ANY ACTIVITIES NOT PERMITTED TO BE CARRIED ON BY AN ORGANIZATIO N EXEMPT FROM FEDERAL INCOME TAX. SAID CORPORATION SHALL BE OPERATED FOR T HE PURPOSES THUS PRESCRIBED AND SHALL NOT BE OPERATED FOR PROFIT. NO PART OF ITS NET EARNING SHALL INURE TO THE BENEFIT OF ANY PRIVATE INDIVIDUAL.

ARTICLE III

A corporation may have one or more classes of members. If it does, the designation of such classes, the manner of election or appointments, the duration of membership and the qualifications and rights, including voting rights, of the members of each class, may be set forth in the by-laws of the corporation or may be set forth below:

ANY PERSON INTERESTED IN IMPROVING AND PROMOTING GOLDFISH POND AND PARK I N LYNN, MA MAY BECOME A MEMBER OF THE ASSOCIATION. VOTING MEMBERS ARE DET ERMINED BY THE RULES SET FORTH IN THE GOLDFISH POND ASSOCIATION BYLAWS.

ARTICLE IV

Other lawful provisions, if any, for the conduct and regulation of the business and affairs of the corporation, for its voluntary dissolution, or for limiting, defining, or regulating the powers of the corporation, or of its directors or members, or of any class of members, are as follows:

WITH THE LAWS OF THE STATE OF MASSACHUSETTS AND RECORDS OF SUCH DISTRIBUTI ON SHALL BE MAINTAINED FOR A PERIOD OF NOT LESS THAN THREE YEARS FROM THE D ATE OF DISTRIBUTION.

Notes: The preceding four (4) atricles are considered to be permanent and may only be changed by filing appropriate Articles of Amendment.

ARTICLE V

The by-laws of the corporation have been duly adopted and the initial directors, president, treasurer and clerk or other presiding, financial or recording officers, whose names are set out on the following page, have been duly elected.

ARTICLE VI
