## 1 CHAPTER

A Stories Prediction: Swindling government money? Corrupt? Or just another bunch of just-us-only egoists. Or the way politics should be?

Tories and the Whigs were created in the 1660s so forever will look at this period with great admiration.

Outright: Any government that takes everyone back to the 1660s is not only bent but not fit for modern times in light of the human rights earned over the centuries. Surely you can't say life in the 1660s is the same as life in the 2020s. A country that relies on the tactics used in the 1660s will find a hidden modern secret digital equivalent of the methods and tactics used then to recreate the times of that age.

It is an undisputed fact that some countries view the 1660s as the best times where they simply gained economic advantage through easy trade in commodities including slaves.

Why would a modern 'civilised government' go back as far as the 1660s?

The element of prediction, a competitive advantage of knowing how the future will unfold simply because they are using a documented script but one only, they know about or one that very few people will know about.

Above all, only they among a few have documented every document and event going back as far as the 1600s thereby giving them a competitive advantage. I think the very argument they have used over years to provide solutions to all modern-day problems is simply comparing events of long ago and the modern ones and using the solutions then. A topic I will devote to later.

But we also know very well about the third-type error where a correct solution is prescribed to a wrong problem. Even if it is a great solution the fact that it is not a correct solution to the problem at hand will escalate the issues. Unless this is the intended way in which it becomes a malicious or deceptive act to gain unfavourably.

I know now this will sound out of context, but it will make sense later.

Straight to the point of the subject matter.

1. The Tories simply visit a time in the past e.g. centuries ago for solutions etc. This is reflected in their policies which are conservative in nature. Not that it is wrong, no. They have the right to be what they are and what they want. But we are saying that too much reliance on the past for everything will always create conflicts, misunderstandings, indirect abuses of power, etc. Simply because we are living in different periods. Picture people in the 1660s; what they want and how they perceive the world then. Now picture a modernised Britain full of foreigners with different attitudes altogether.
2. I know one would argue that there is nothing wrong with that and it is only a matter of finding the right balance between balancing the conservation of a people's culture and way of living and the integration of modern systems. But this applies only if it's about balancing the past and the future. But in the case of the Tories, I argue that it's more of going back to the 1660s and finding ways of accommodating the modern times into this 1660s mindset. It's not about balancing no but about modernizing the 1600s. Finding digital solutions that represent the 1600s and using this to recreate the 1600s. A perfect example is the use in humans of drone technology, digital hacking, and electromagnetic nerve tampering where in the name of

medical records everyone is chipped at birth and then goes on to be abused throughout life remotely. If they complain they are regarded as hallucinating simply because they thought it could not be proved. Then replace all traditional techniques of torture like hooding with a cloth with a digital form of hooding where the chip with rotary functions will twist the eye iris at an angle to the eye socket so that vision is lost even if the eyes are open as the eye iris is hidden inside the eye socket. Or white noises whereas with the traditional one's noises are used to confuse and stress a person to breaking points. Now they do the same using the chips to replay recordings in the person's ears deep inside and at a low volume that it is heard as inner voices. All this is made possible by a Blackbox so small that it is part of the chip. The recorded songs are then replayed to that person and only that person can hear this. In some cases, the recordings are replayed as a person is deep in sleep as in hypnosis in that the person when hearing these small voices the brain will convert these into pictures so that the person thinks he or she was dreaming. This is important in that this will also explain the rise of terrorists who if the inner small voices are played to them, might believe for real that it was a message from Allah. Ever wonder why terrorism is associated with very religious people? Could digital technology be the basis of all this or is there a real God or Allah commanding these people to go and kill others?

3. We also know for a fact that most foreigners born in this country are secretly hacked on birth without consent etc. simply because they are foreigners. The fact that they insist on hacking as a way of becoming British through the demands of the monarch and pledges to the monarchy. It can be argued that chances are that all foreigners born here are chipped. I don't care for whatever reasons. The Russia/Ukraine war has highlighted drone technology and its uses. Could the claims of the early 2000s be regarded as truthful that the West are implanting miniature versions of plane parts in humans namely; a miniature rotary propeller the size of the top index finger implanted at birth on the

4. Another form of torture is the use of food and water to control the people. Traditionally it would involve the withdrawal of these physically, but the modern version would be to use all the parts mentioned above. The GPS tracks everywhere where the person has gone, everywhere the person gets help and every possible place of help and uses the chip to identify phone numbers around the radius of the position of the subject and phone all not to help that person in a digital scorched earth policy.
5. I mentioned that above so that you have a clear view of the issues to be discussed below. You can see outright that the technology exists and therefore what will be argued below is not hallucinations as they will try to convince you. But the reality is that the Tories are busy looking for advanced digital technologies that do the same acts as in the 1660s when they benefited from free labour and easy control of the people through force. But this is not the main topic of this document. Our concerns are with the trickery that this produces.
6. To prove that we are telling the truth we will predict what the Tories will do and how they arrive at such a decision. We will give you concrete examples of the past in the 1660s.

### Our Tories Predictions.

1. Will swindle money from the government. Taxpayers' money by creating scandals and resigning at a cost to the taxpayers of around £230 000 [2x115000] per year for life. We believe the resignations have not stopped. Even the current prime minister might resign [19 November 2022] and be replaced by another Tory member. All this is at the expense of the taxpayers. Ok, governments make mistakes but what if they have created a loophole deliberately?

2. What matters even if they lose in the 2024 elections when four or five of them are still being paid a prime minister's salary or pension?
3. The insistence on being a member of the Church of England will see the prime minister secretly promise to change religion if he has to remain in power or this will be his reason to resign so that Torie's field another candidate to take the prime minister role all this at the expense to the taxpayers. That the current prime minister will be given a pension for life and the new prime minister and all those who resigned will also be entitled to the pension.
4. The current prime minister will try to introduce religious freedom at number 10 but this as I said might be the source of tension since he has a different religion.
5. By 2024 the Tories will have fielded 5 prime ministers most through resignations with a pension of around £230 000 – £575 000 per year for life.
6. The UK prime minister will offer to train 6000 Ukraine civilians as military personnel for a fee of £160 000 per year.
7. The prime minister will introduce a health fee of £10 of some sort [hearth tax].
8. The prime minister will favour the Russia and Ukraine war and religious freedom, and these will bring him into conflict with English members of parliament.
9. The prime minister will try to change some restrictive laws but will come into conflict with parliament. He will be challenged that the prime minister does not have powers to reverse laws passed by parliament.
10. The prime minister will encourage and support the war for England to gain a better trade position as its two major competitors in Russia and Ukraine will have been taken out of the picture. But over months and years will not benefit from this war.
11. The parliament will oppose the prime minister regarding him as interested in foreign affairs rather than the welfare of the British people who at some point will oppose any foreign aid as things become tough at home.

12. The prime minister might be bribed with a pension to resign and let an English person be put back as prime minister to keep things as they were.
13. The prime minister will focus more on health especially in the investigation of blood-related outbreaks, increasing testing centres, and showing interest in scientific pursuits.
14. The UK will now under this prime minister put more focus on the space race aiming to be the number one through funding of space projects.
15. Under this prime minister, the government will increase personal surveillance with more cameras making England a big brother nation where they observe people.
16. Absolute government. This government will try to abandon all international laws in favour of local laws.
17. People will refuse to pay taxes just as they will declare that as a family, they did the same.

Proof that the Tories are going back in time to the 1660s and recreating events to get a competitive advantage.

RECREATION OF THE 'CABAL' KNOWN AS THE SKRPT  
Our arguments that the Tories are going back to the 1660s for answers is evidenced by their recreating of the CABAL during Charles II of England but one we gave the acronym of SKRPT based on the initials of the group. Moreover, this SKRPT went on to take important posts in the government. The main emphasis is that they went on to take top positions in the government. King Charles II had a privy council that is a private council to advise him. He had five members going by the acronym of CABAL. These people could run the country effectively and most were closely linked to the monarchy. So, in fact, they were there to represent the interest of the monarchy. To source funding for the monarchy through customs and excise duty and other innovative taxes like the Hearth Tax. This is because the income the King received from Parliament wasn't enough. At the time of 1665-1670, the King had an annual income of £1,2 million. This wasn't enough and worse the money was received way too late he had to go some time without these funds. This meant that he had to rely

mainly on customs and excise duty funds. The cabal was a private group that enabled the King to ignore and dissolve the Parliament as these were capable of running the country.

This group worked as one powerhouse where power was equally shared among the five including the King. This meant all working together as one. All felt equally important and would all share responsibilities and tasks. In light of this information, you can see that they all would give each other a chance. That means if one fails then the other knowing that part of the group is equally important would step down for the other. That means each giving the other a chance. They all worked together for one goal and the King then even encouraged them to fight and quarrel as a way to deceive the people so as if they look like in-fighting only because they were to raise money for the king that could have attracted more scrutiny from the people. The CABAL's main task was to overhaul the King's finances. The King had chosen CABAL over the Parliament because the Parliament did not offer the King enough money to run the country. A budget of £1.2million was not enough for the king. So, this CABAL felt privileged to be chosen over Parliament as the king kept dissolving Parliament in favour of these. To keep in the king's favour, the CABAL had to do more for the king. Money was a big issue due to the First and Second Anglo War and the plague of 1665 and the Great Fire of London 1666. To be in favour of the king the CABAL had to be innovative and find new sources of income for the king. To supplement his income to run the country the king introduced a Hearth Tax among income from customs and duty.

## SKRPT

The SKRPT is the modern version of the CABAL; young, ambitious, and energetic but just like the CABAL there to serve the Prime Minister [PM] in modern times. That is to find ways of generating money for the PM. The former PM appointed all the members of the SKRPT into government. If they are following the CABAL script it follows also that they are there to serve the interest of the PM who appointed them. Meaning that just like the CABAL there are there to look for money for the PM. The CABAL was a private group capable of running the country

just as the PM.

Just like the CABAL, their utmost loyalty is to the PM, the one who appointed them. Even though they might have conspired to force the PM to resign, their interest is for the PM. We believe that all this was a calculated plan.

1. The PM faces a financial crisis with inflation and Britain at risk of a recession. We believe that the plan was for the PM to temporarily step back and resign through a scandal. Since power is shared between the PM and the five members of the SKRPT. If the PM steps down any member of the SKRPT would step in his shoes and create means for fundraising for the PM knowing that he would return and take over. This means implementing controversial policies.

Financial Exigency. This means the need for drastic means to deal with the dire financial situation. This triggers the need to levy taxes.

The Clever bit. [Just an opinion]

The idea from the word go is to increase taxes to close the deficit gap through taxes. But increasing taxes makes a PM very unpopular. So, credibility and trust of the PM are very critical here. The PM might have promised that he would not increase taxes, but he needs to plug the gap between income and expenditure and this can only be done through increased taxes. So, the PM recruits the SKRPT. Ever heard of those managers to save their face who hire a friend to sack the friend and gain an advantageous position? But the plan here is to offer 'imaginary tax cuts' first to raise the hope of the people in a psychological manner in which corporations and wealthy individuals will welcome the tax cuts with open arms. But the PM can't offer tax cuts because everyone knows that he is in a financial black hole. So, through a scandal, he resigns after secretly negotiating with one of the SKRPT for the SKRPT to come in and do his dirty work but quits too after the dirty work has been done. The view is that when one of the SKRPT

resigns people would put the PM back who then goes on to increase taxes even higher than they were before the mistake of the SKRPT.

King Charles II entered into a secret treaty with king Louis XIV where he was promised a pension of £230 000. If the PM would help one of the SKRPT both would earn a pension of £230 000. [2x115 000].

The current pension for a PM is only £115 000 and to be able to follow the 1665-1670 script, resigning from office would make sure that the pension to the PM and one of the SKRPTs would be double that to £230 000.

b) Trickle-down economics.

### Trickle-Down Economics.

These are economic policies that are adopted and implemented that offer huge tax subsidies to the highest earners, the upper-income class, huge corporations, and wealthy individuals in the hope that this increases growth and then the benefits gained by these upper-income groups will be trickled down to the poor people. In this case, governments offer huge tax cuts to the top brass hoping that these in turn will offer benefits also to those at the lower levels. The method advocates for tax cuts or lower taxes for corporations and rich individuals who in turn would create more jobs etc and all this is believed to benefit the lower-class people.

a) The abolishing of the 45% higher tax income.

b) Lifting of the stamp duty threshold.

We can only infer that it was to offer the biggest tax cuts to the rich and corporations by abolishing the higher rate of income tax paid by everyone earning above £150 000 a year. The government will then have to borrow large sums at ever-increasing expensive rates hoping to use government powers in the future to stop the exchequer. Meaning using government powers to stop repayments for twelve months citing reasons like say the funding of the Russia/Ukraine war or a higher budget deficit. Hoping that in the end all this would simply be regarded as the economic national debt that will be paid off in years to come. Resign to let a bad but critical decision be taken by your successor and then return after the decision has already been taken and the successor had resigned then correct and go further than resign status.

Once back in power then actually increase taxes even higher than they were before.

Even though in this situation the PM did not return to take his initial PM position, the next PM who took over now drastically implemented policies to correct the mistake by actually increasing even higher taxes. This way the corporations and higher earners would not complain that they would feel like the government was willing to offer them a tax cut so they would not mind paying even more taxes in return.

### SOURCES

OF REVENUE CUSTOMS AND DUTIES [ literally] as in customs of the conservatives or customary to the conservatives for corporations and high earners to donate funds to the Tories as their duty.

I mentioned above that the King's allowance of £1,2m wasn't even so he needed other sources of income. Above all, there were not enough ways the King would collect or get this money from the parliament. So he emphasised the collection of customs and excise duty.

It is absurd to think that giving corporations extra money in tax relief will see the poor or middle class benefiting from this. If the government wants to reduce inequality it will cut tax rates for this group. No evidence that offering corporations and wealthy citizens tax reductions will result in reduced poverty among the people. We believe all this is to bribe corporations and wealthy individuals in a scratch my back and I will scratch yours act where the Tories will say we reduce taxes for you so donate to our party.

1. We also believe that the tax cuts are meant to make corporations, banks, and wealthy individuals feel free and easy to lend and to offer loans to the Tories. We also believe that at some point the Tories might default to repay these loans. Or defer payment making some of these corporations bankrupt etc. Just an opinion.

## THE GOLDSMITH BANKERS AND THE STOP OF THE EXCHEQUER

King Charles II faced financial problems namely, a lack of funds and the need to fund the Third Anglo-Dutch war so he delayed debt repayment for 12 months this made some goldsmith bankers go bankrupt.

Could the tax cut to corporations and the wealth be a bribe and incentive for them to donate to the Tories in the future? Or just a means to increase production and imports to increase the custom and excise duty?

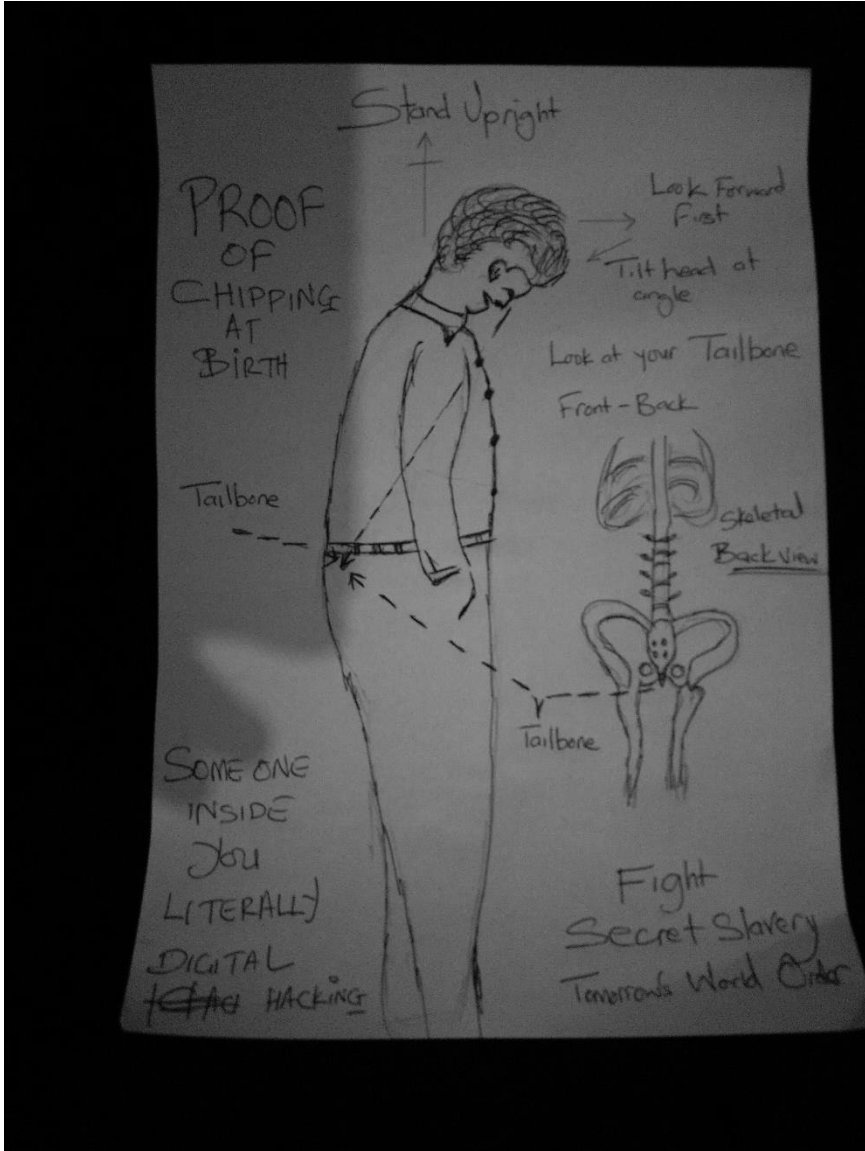
We devised an easy way to check. Follow these easy steps and find out for yourself.

6. **Leaders, organizers, instigators, and accomplices participating in the formulation or execution of a common plan or conspiracy to commit any of the foregoing crimes are responsible for all acts performed by any persons in the execution of the such plan.**

7. **That includes everyone including the local police of all countries and the hospitals who might be helping them enforce and carry out all these.**

8. We as Tomorrow's World Order argue that a lot of things have changed since these statutes were implemented and we want the court to look at these issues in light of the changing environment and amend these regardless of the **gravity of the crimes** as they threaten the fabric of human existence.

9. *A reasonable basis to initiate an investigation in the interest of justice. Pandemic.*

11. Failings and creation of conditions that fuel the virus are not only evils but fall under crimes against humanity murder meaning **mass murder** and or genocide to some extent areas the court has jurisdiction to act upon. 12. WHAT ARE CRIMES AGAINST HUMANITY?

13. *Crimes against humanity refer to specific crimes committed in the context of a large-scale attack targeting civilians, regardless*

*of their nationality. These crimes include murder, torture, sexual violence, enslavement, persecution, enforced disappearance, etc. Crimes against humanity have **often been committed as part of State policies**, but they can also be perpetrated by non-State armed groups or paramilitary forces. Unlike war crimes, crime against humanity can also be **committed in peacetime**, and contrary to genocide, they are not necessarily committed against a specific national, ethnic, racial, or religious group.*

14. ICC WEBSITE.

15. These crimes **were committed after 1 July 2002**, the date of the entry into force of the Rome Statute, the Court's founding treaty; the crimes took place in the territory of a State Party or **were committed by a citizen of a State Party**. They **amount to crimes against humanity or genocide; the gravity of these crimes means that they must be investigated asap.**

16. Where the State is the vehicle of persecution and mass murder there is no talk of local or national redress nor investigations and prosecutions as the state itself is the one responsible.

17. *[National authorities bear the primary responsibility, in the first instance, to investigate and prosecute those most responsible for the commission of mass crimes. The Court will initiate investigations, in accordance with the legal criteria set by the Rome Statute, only when the national authorities have failed to uphold this primary responsibility and in the absence of genuine national proceedings.]*

18. But if they are the ones responsible and ordering the shutdowns then the talk of national redress is non-existence. Therefore, the court is obliged to look at this as this has gone global.

19. We as Tomorrow's World Order believe that there is a criminal intent to kill people deliberately or indirectly. Such reckless acts whether deliberate or due to sheer ignorance cannot be tolerated or left unpunished. We strongly believe that nevertheless how natural the pandemic might seem to people. We strongly believe that there is a malicious criminal intent by these governments and their leaders to kill as many people as they can for the following reasons:

20. To hide evidence of human hacking.

21. To get rid of the so-called 'dead-wood' in the pensioners, people who make most of the government expenses in pensions, etc.

22. A population control mechanism.

23. We strongly believe that the Lockdowns are being enforced too.

26. Are they deliberately trying to kill as many as they can? Do they have a target number? Say 100 000 in a country like England? This is not speculative; we will give you our basis for suggesting that. See below arguments considering the 1665-1666 England pandemic.

27. We strongly believe that it is well known to all that since this is a viral pandemic **ALL PROPOSED AND IMPLEMENTED "SOLUTIONS" HAVE THE EFFECT OF FEEDING THE VIRUS.** 28. We believe that if it was a **BACTERIAL INDUCED PANDEMIC** yes, the solutions including lockdowns "might" have worked. But this is a **VIRAL** pandemic and all these leaders with a bunch of advisers etc. must know that.

a. Lockdown reduces the body's ability to fight infections.

b. Reduces the body's natural ability to defend itself against viruses.

c. No exercises. Even general walking is cut off by the forced lockdowns and the enforcement. Leaving the body exposed without the protective shield.

d. Lockdowns themselves induce stress that weakens the person. The very reason why they lock people in jails especially those associated with murder or violent crimes. To weaken them in all the meanings of the word.

29. WE STRONGLY BELIEVE THAT THE APPROACH ADOPTED IS FLAWED. In that, they LOOKED AT THE VIRUS INSTEAD OF THE HUMAN IMMUNE SYSTEM. We believe this is deliberate to have the greatest impact. Meaning killing more. Looking at the virus will only result in these leaders finding ways of avoiding the virus. WE BELIEVE THEY SHOULD HAVE LOOKED AT WAYS TO BOOST THE HUMAN IMMUNE SYSTEM.

30. Surely if isolation and lockdown will weaken the human immune system as people exercise less. As people worry too much.

As the sources of comfort and boost to self-esteem are restricted e.g. in seeing emotional support in friends and family. Then they would not have proposed and implemented lockdowns. But because they looked at the VIRUS rather than the people's defence system this has become a THIRD-TYPE ERROR. Yes, they have solutions but for a different or wrong problem. They are doing something but it's all wrong in this case. Fuelling the pandemic and deaths.

31. BUT WE BELIEVE IT IS INTENTIONAL AND ALL MUST BE HELD ACCOUNTABLE. This is the very reason why people were put in concentration camps. THE LOCKDOWNS SECRETLY CREATE THE CONDITIONS WHICH WE CALL 'BREEDING GROUNDS FOR THE VIRUS.

32. Yes. This method might have worked if this was a bacterial outbreak. The fact that they all know this makes us bring all 200 plus to you one by one. We know it's a lot of work but that is the very reason why you are there. You have our support all the way. No one is above the law. Send a clear message. To assess and bring all to trial for the following crimes. a. Mass murder depending on circumstances.

b. Holding their citizens as hostages and under indirect house arrest. The enforcement supports this. This is hostage-taking.

c. Forcing their citizens against their will, breaching their human rights, and putting them all at risk of death by weakening them through the forced lockdowns. Humans hack and try to or getting rid of the evidence by forced lockdowns knowing that most are likely to die. We believe this is an attempt to destroy secret human hacking evidence that used to be done secretly. A good example is the strictness of lockdowns in Britain in likely opposition countries namely Scotland and Wales where they might be the hardest hit by the pandemic. It does not matter how and who started the pandemic. They might all have seen an opportunity and taken it globally as well.

33. To us, as Tomorrow's World Order we believe that the best way is to look at the best way to build the HUMAN DEFENSE SYSTEM NATURALLY.

a. This would have meant.

b. Strengthening the human system. Immune system meaning.

i. No lockdowns but people are allowed to stay outdoors in the open or very well-ventilated places etc.

34. Withdrawing of financial resources at the time of the greatest need. The poorest even in developed countries have become hard hit in some countries with charities taking a leading role to feed the children and women etc. No financial backing for the ordinary people and the governments choose businesses more. Lack of a duty of care towards these people especially women and children.

35. We know during pandemics things can be hard but doing more damage is not only evil but a criminal offence. There are greater expectations from these leaders and there is a need for greater responsibilities. When that fails this not only amounts to incompetence but a crime.

36. We are basing our answers on the fact that this is a viral pandemic and just like any virus illness like the cold. The body will get rid of the virus by itself. No medicines work against the cold virus itself. That is why colds are still here now. All medicines tend only to alleviate the symptoms. So, likewise, everything should have been done to help boost the immune system. They had this knowledge a year ago. They waited. That brings me to another accusation.

1. Procrastinating and waiting for the virus to do maximum damage first before acting and when they did it was the wrong kind of action.

2. These recommendations are in line with the fact that a year has gone, and they are still recording the greatest daily infection and death rates. Surely that means something is wrong. We are not saying that people won't die but we believe in strengthening the people naturally not by limiting movements and exercises which have a direct impact on the immune system and the ability of the body to handle the virus.

3. Lockdowns only make people take longer to develop a natural defence system without vaccines. There would be more cases of the Covid virus but reduced deaths.

4. The adopted method would have fewer Covid cases which also MEANS fewer PEOPLE WHO ARE NATURALLY IMMUNE TO THE virus and more extreme deaths. The very argument of our case. See attached graphs for proof.

37. Another crime is that of the third type of error.

38. Deliberately misleading the people. Pretending to tackle the pandemic but making deals and distributing wealth into the community money that would end up back to their Trusts, legacy organisations, or party politics one day. This is because they will or might deliberately purchase useless e.g. protective gear against the virus. Then pretend it is because of the pandemic meaning lack of time etc. and many will be recommended by their party people or suppliers. They will deliberately choose wrong solutions to scare people as deaths

increase weakening them not to protest but to submit and not point to corruption or misuse of government funds.

39. Lockdowns instead of less time indoors can amount to a criminal offence depending on the number of deaths, duration, and if forced or not. If enforced or not etc.

40. Misuse of government money. All the beneficiaries must be investigated. Links established as to trust, legacies, political parties, etc. All vaccine companies are to be investigated too. 41. The other crime is to apportion blame. Taking advantage of the viruses will make people partly blamed for their creation. If the

64. I think the time frame will rule out most of the above defences. If it was acts done in the first weeks of the pandemic maybe. But a year after no justification must stand. All must be found liable for the above crimes. We recommend the court treat these like any president or prime minister who has carried out crimes against humanity, war crimes, genocide, etc. These crimes are gross, and we must not let any get away with intentional murder. No one must decide who must die and when.

65. Some of them will use the argument of seeing the real threat posed by the pandemic first-hand.

66. As such might argue that they acted in response to the threat at hand. Meaning actions were to save people. They can argue that **THEY WERE INFECTED BY THE VIRUS**

**THEMSELVES AND THEREFORE A VICTIM MEANING THEIR ACTIONS WAS IN RELATION TO THE “INSTANT TRAUMA OF THE NEAR LIKE DEATH**

Often the first to contract among the leaders might be suspect. We leave this to the court.

To have a leader...mind you where it originated it is associated with homelessness, dirty people who don't wash their hands, body clothes, etc. Mainly people with poor standards and then a leader being the first one might mean a deceptive act on the part of that country. 74. First to have developed the first method to detect this etc.

75. First to have found the vaccine.

76. First to have discovered a new variant.

77. First to have developed a cure.

78. ALL THESE AMONG A SINGLE COUNTRY OUT OF THE POSSIBLE 200 IS SUSPECT. 79. The questions you might want to ask are these.

80. Are they the source? Look at history and documented cases of a similar pandemic. 81. Look at the circumstances. The position they are in would have justified creating a lethal pathogen virus to clean the country and gain a favourable position. A competitive advantage. To herald the announcement of a world leader by holding everyone to ransom. Killing to show power globally and

using the virus to silence other world leaders or opposition. Using the virus to show who is boss even if the virus was natural, they might have created digital or bio-modified to hide behind the original one.

82. I think it is suspect to have everything being first in one country and worse to find a new variant. Mind you we are not talking about a third-world country with poor standards etc. 83. So, we leave the courts to handle this considering the above statements. 84. the court must bring to trial all 200-plus world leaders one by one on an individual basis. It is a crime and as per Tomorrow's World Order, they must all pay if guilty now rather than wait until they are old. We are proactive. We expect the court to act and ACT FAST when the evidence is still there rather than come years later and try to find out what happened. A crime is being committed right now on our watch. The question is what the courts can do. Are they going to change their approach of waiting or might want to modernize even if that means expanding etc.?

85. We have in the past highlighted the issues we have with the court's past dealing with culprits. The law sees no colour or status if a crime has been committed. We speak and stand for everyone and especially the voiceless, yet the most valuable are the women and children often seen as vulnerable and weak. Who ends up like that because the courts and the justice system often favour the elite, wealthy and powerful leaders?

86. Let not any intimidation and sanctions stop you. Only the law shall prevail. Justice shall be the norm under Tomorrow's World Order. A new start. A new beginning. 87. Note that.

94. They should have at least encouraged this to happen naturally by providing an environment just for that. Less stress, more help, and financial resources and support. It is not about the virus but the system. The human immune system.

95. We know this might stretch the resources of the courts, but this is the future the court must modernize too. Greater responsibilities, and greater expectations on your part too. 96. Being ignorant and trying to frustrate change just for the sake of it when all that we stand for as Tomorrow's World Order will benefit the people at large bringing wealth to all mankind to levels never thought of
