**APPLICATION FOR RESERVED PIT PARKING SPACES**

RESERVE PARKING SPACES FOR THE **2024** POINTS RACING SEASON WILL BE AVAILABLE AS FOLLOWS:

SPACE WILL COST **\$100.00 EACH YEAR**. IT IS RECOMMENDED THAT PARTICIPANTS PROVIDE THEIR OWN SIGN, NOT TO EXCEED 30" SQUARE. NO PROFANITY ALLOWED

1. RENEWAL YEAR: **2024** **\$100.00**
2. SPACE MAY BE RENEWED TO PARTICIPANT/RENTER FOR THE FOLLOWING RACING SEASON AND THEREAFTER ONLY IF:
  - A. MANAGEMENT DECIDES TO CONTINUE WITH RENTAL PROGRAM
  - B. SAID PARTICIPANT/RENTER PURCHASES A NEW BETHEL SPEEDWAY MEMBERSHIP FOR THE SAID SEASON BEFORE OPENING DAY.
  - C. A FEE OF \$100.00 PAID FOR SAID SEASON BEFORE OPENING DAY.
3. **SPACE CANNOT BE "SOLD", "SUB-LEASED" "BORROWED" "TRANSFERRED", "GIVEN AWAY", ETC. TO ANYONE ELSE BUT ORIGINAL PARTICIPANT/RENTER.** IF SAID PARTICIPANT/RENTER SELLS, TRANSFERS, GIVES AWAY, ETC. RACING VEHICLE SAID SPACE DOES NOT GO ALONG WITH VEHICLE. SAID SPACE WILL RELINQUISH BACK TO TRACK MANAGEMENT.
4. MANAGEMENT RESERVES THE RIGHT TO DENY ANY REQUESTS FOR RESERVED PARKING.
5. THE MANAGEMENT RESERVES THE RIGHT TO REVOKE AND CANCEL ANY PARTICIPANT/RENTER SPACE AT ANY TIME DUE TO PARTICIPANT/RENTER NOT COMPLYING WITH RULES INCLUDING AND NOT LIMITED TO CONDUCT AND BEHAVIOR POLICIES SET FORTH IN BETHEL MOTOR SPEEDWAY'S RULE BOOK. REFUNDS WILL NOT BE GIVEN.
6. **SAID SPACE MUST BE KEPT CLEAN AND FREE OF ANY GARBAGE, CIGARETTE BUTTS, DEBRIS, ETC.** ABSOLUTELY NO DUMPING OF ANY KIND.
7. NO IMPROVEMENTS, ALTERATIONS OR CHANGES OF ANY KIND CAN BE MADE TO SAID SPACE UNLESS PLANS ARE PRESENTED IN WRITING TO TRACK MANAGEMENT AND APPROVED BY TRACK MANAGEMENT.
8. SAID SPACE IS ONLY AVAILABLE TO PARTICIPANT/RENTER DURING REGULAR OPERATION HOURS, **DURING THE REGULAR POINTS SEASON ONLY**, FOR THE PURPOSE OF UTILIZING IT WHILE PARTICIPATING IN THE RACING EVENT. **IF YOU'RE NOT RACING WITH YOUR CAR, SAID SPACE WILL REMAIN EMPTY. NO PERSONAL VEHICLES PERMITTED TO PARK IN SAID SPACE. NO EXCEPTIONS.**
