PRIMARY COST:

The cost of the "Walking in the Footsteps of Paul" program is \$2450 + Airfare. All travelers will be paired with a roommate if possible; the single-occupancy rate is an additional \$650 for those wanting and requesting single-occupancy (\$2750 + \$650 + Airfare). If you request a triple-occupancy (couple with child) you will have a \$200 discount per person.

AIRFARE:

All participants are responsible for arranging their own airfare and need to arrive at the Athens International Airport in Athens, Greece on or before June 20, 2024 and depart on or after June 29, 2024 from Athens International Airport. We will coordinate airport pick-up times for June 20, 2024 and drop-off times on June 29, 2024 with Aristotle Travel Agency. Once participants have booked their flights, they will need to send the flight itinerary and information to Jon Hackett at jonphackett@gmail.com.

CANCELATION POLICY:

Should you decide to withdraw from the program, the following cancellation penalties may apply:

60 to 46 days prior to the tour start date – 30% of total tour cost: \$735.00 cancellation penalty. 45 to 31 days prior to the tour start date – 65% of total tour cost: \$1592.50 cancellation penalty. 30 to 16 days prior to the tour start date – 85% of total tour cost: \$2082.50 cancellation penalty. 15 days or less prior to tour start date – 100% of total tour cost: \$2450.00 (no refund) *No refund is given to "No shows", will be charged at full cost.

FAQs

Q: Who can participate in the program?

A: This trip is sponsored by the Lomax Church of Christ in coordination with the Glyfada Church of Christ and the Mediterranean Christian Conference coordinators, but is open to anyone who would like to attend. Any minor under the age of 18 must be accompanied by a parent or legal guardian. Any participant needs to be physically and healthy enough to walk short to medium distances, flights of stairs, and be able to get on and off buses easily.

Q: What do I need to do to sign up?

A: Full-paying participants should complete the registration form and return it to the Lomax Church of Christ Office with deposit as soon as possible, but no later than **January 15, 2024**. The deposit will reserve a spot, and a limited number of spots are available for full-paying participants. Submit your registration form to jonphackett@gmail.com to confirm availability before paying the deposit.

Additional forms and participation requirements will be communicated to all travelers during pre- departure orientation.

Q: What do I do about airfare to Athens, Greece?

A: Each participant is responsible for arranging their own airfare to Athens International Airport "Eleftherios Venizelos." If you don't have a travel agent that you already work with you can contact Angeli Lingaria at MNT Travel. Angeli's direct line is (954) 369-4832, email is Angeli.Lingaria@flymnt.com., and website is www.mnttravel.com. She can help arrange your tickets for the arrival and departure times you need. Make sure to mention that you are traveling with Jon Hackett's Israel 2024 trip.

Q: When do I need to apply for a passport?

A: Participants who do not already have a passport should begin the passport application process immediately. The Lomax Church of Christ Office **must** have a valid passport copy from all participants by **April 15**, **2024**. Instructions for submitting a passport copy will be provided by email. For information about how to apply for a passport, visit travel.state.gov/passports.
