

City Temperature Of 96 Again Sets Day's Record

For the second straight day, the temperature in downtown San Diego yesterday peaked at a record level. But a cooling trend has set

in. Ray Robben of the National Weather Service said temperatures in coastal and inland valleys today should drop by up to five degrees as Santa Ana winds diminish, with further cooling along the coast tomorrow.

The high at Lindbergh Field yesterday, after a low of 69, reached 96. This was three degrees above the previous record for Sept. 24 set in 1968. The current heat wave, which began Monday, produced a high of 103 on Tuesday, also a record.

The highest reported temperature in the county yes-terday was 105 in Spring Valley. Escondido recorded 104; El Cajon and Fallbrook, 103; La Mesa and Lemon Grove, 102; Lakeside and Vista, 101; Montgomery Field, San Diego State University and Poway, 100.

Borrego Springs checked in with 99; Alpine, 98; Chula Vista, Coronado, Ramona and Carlsbad, 96; National City and Oceanside, 94; Point Loma, 93; Del Mar, 90.

It was a cool 70 on Mt. Laguna, and 78 on Palomar Mountain.

The heat prompted many elementary and high schools to send pupils home early.

STORE EMPLOYE ROBBED, LOCKED IN CAR TRUNK

Two men and a juvenile were arrested yesterday in connection with the robbery of a College Grove store employe who was locked in the trunk of her car for about 15 minutes, police said.

Booked in county jail on suspicion of robbery and conspiracy were Lonnie Lee Ford, 18, 5216 Solola Ave., and Darryl Edward Mason, 19, 5065 Reynolds St. The juvenile, 17, was taken to Juvenile Hall.

Agent Role

Rivalry between San Diego's two major teachers' organizations began yesterday over which one would gain the right to be the exclusive bargaining agent for the city's 6,076 teachers.

Under provisions of a bill (SB 160) signed this week by Gov. Brown, teachers will be allowed for the first time to participate in collective bargaining. But only one organization can be designated to represent them.

Teachers currently voice their negotiating demands through a council comprised of four members of the larger San Diego Teachers Association and one member of the San Diego Federation of Teachers, an AFL-CIO affili-

Unions Seek 4 Brushfires Of Teachers In County Still Uncontrolled

Fanned by gusty Santa Ana winds, four brushfires, one of them on the North County boundary line and another to the extreme south near Tecate, were burning out of control late last night, officials said.

The latest brush and grass fire started at 3:30 p.m. yesterday on State 94 between Barrett and Tecate Junctions and within a few hours burned over 2,000 acres.

The California Division of Forestry said some families in homes near State 94 and between the two junctions were evacuated and taken to Las Flores School on Lyons Valley Road in the Jamul area.

More than 300 state forestry and U.S. Forest Service fire fighters were on the fire lines. About 100 families in the Barrett Lake trailer park were advised to leave when flames threatened the park.

At one time last night, flames were reported burning almost completely around the 1,000-acre Grapevine Ranch just off State 94. The ranch is owned by Dick Martin of San Diego, who also owns the San Diego Coin Exchange. No buildings on the ranch were reported burned.

The fire was on both sides of State 94 and the California Highway Patrol closed the highway and admitted only emergency vehicles. Sheriff's deputies were standing by to assist those who wished to get out of the threatened areas.

Late last night Bob Robeson, one of the state forestry fire bosses, said the wind had lessened but if it shifts and gets stronger "we could be in real trouble."

State 94 was closed from Barrett Junction to Tecate for a period but was later opened to traffic.

Some animals and poultry, including 300 sheep, were taken out of the area of Round-Potrero Road.

According to last reports, the fire was burning in two extensions, one around the Tecate Peak fire lookout and the other up to the Grapevine Ranch.

Fire officials could give no estimate on when the blaze might be contained

Another major brush fire Monday still burning started in De Luz Valley just off the Tenaja Truck Trail in the northwest section of the county.
