- 1. I understand and agree, that in the event of an emergency, Tail Waggers Bed n Breakfast will first attempt to contact the owner, seconded by an attempt to contact the emergency contact of record, then the veterinarian of record, or an emergency veterinarian if it is determined that immediate treatment is necessary. Tail Waggers Bed n Breakfast maintains sole discretion, without liability, in emergency matters. I agree to pay for all medical treatments received, including transportation to a veterinary facility, promptly upon picking up my dog. I hereby agree to reimburse Tail Waggers Bed n Breakfast for veterinary costs, whether specifically authorized or not, in an amount which will be unlimited.
- 2. For senior and/or chronically sick pets: I understand that there are inherent risks in boarding a senior or chronically sick pet. Underlying health problems can be exacerbated by stress. Illness or infections which would be minor in a healthy pet can become serious and even life threatening in an elderly or frail pet.
- 3. I understand and agree that Tail Waggers Bed n Breakfast and its staff will not be held liable for any problems that develop (e.g. injuries, fleas, ticks and illnesses) during my pet's stay at Tail Waggers Bed n Breakfast.
- 4. I release Tail Waggers Bed n Breakfast of and from any and all responsibility for releasing my pet to any person whom I have authorized.
- 5. Tail Waggers Bed n Breakfast shall exercise reasonable care of your pet while boarding. It is agreed by the owner that Tail Waggers Bed n Breakfast 's liability in no event shall exceed the sum of \$200.00 per animal boarded.
- 6. Storm Disclaimer: In the case of severe weather conditions, Tail Waggers Bed n Breakfast cannot guarantee the safety of owners' pets. Tail Waggers Bed n Breakfast agrees to make every possible effort, without endangering kennel staff, to care for animals entrusted to us.
- 7. This contract contains the entire agreement between parties. All terms and conditions of this contract shall be binding on the heirs, administrators, and personal representatives of the pet owner and Tail Waggers Bed n Breakfast.
- 8. I further understand that if my dog is left at Tail Waggers Bed n Breakfast for a period of 72 hours beyond the agreed pickup date, without contact from the owner, this dog will be considered abandoned and necessary steps will be taken to turn the dog over to the proper authorities or to place the pet in another home.
