AN ORDINANCE PROVIDING FOR BUDGET AND APPROPRIATIONS OF BERKELEY PARK DISTRICT, COOK COUNTY, ILLINOIS FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2024 AND ENDING DECEMBER 31, 2024.

WHEREAS, the Board of Commissioners of the Berkeley Park District, Cook County, Illinois, caused to be prepared in tentative form a budget, and the Secretary of this Board has made the same conveniently available to public inspection for at least thirty (30) days prior to final action thereon; and

WHEREAS, a public hearing was held as to such budget on the 6th day of March, 2024 and notice of said hearing was given at least one (1) week prior thereto as required by law, and all other legal requirements have been complied with:

NOW, THEREFORE, be it ordained by the Board of Commissioners of Berkeley Park District, Cook County, Illinois, as follows:

SECTION 1: That the fiscal year of this Park District is hereby fixed to begin January 1, 2024 and end December 31, 2024.
