July 20, 2022

CALL TO ORDER: President Blake Lindsay called the meeting to order, quorum present. The purpose of the meeting was to review options and make decisions regarding our club's return to Methodist Hospital for meetings.

PP Diana Ezzell met with Methodist Hospital to determine the feasibility of club meetings resuming at the hospital as early as this fall. Based on her meeting, she prepared options and costs for discussion by the board. One hurdle involved remaining meeting dates in 2022 when the hospital is not available. Alternate locations for those meetings were discussed and will be decided at a later date, as needed.

After discussion by the board, President Blake Lindsay recommended returning to Methodist Hospital on a semi-monthly basis until the end of 2022 and returning to meetings every week at Methodist Hospital beginning in 2023. Lunch will be once again included in the dues.

To formalize these recommendations, the following motions were presented for a vote.

Motion 1: Return to Methodist Hospital beginning September 14 for regular meetings on the 2nd and 4th Wednesdays of the month with meals included in the dues; alternate locations designated as needed when Methodist Hospital is not available. PP Diana Ezzell motion; 2VP Bobby Allen second. Motion passed.

Motion 2: Restart \$50 dues structure, which will include meals, beginning September 1. 2VP Bobby Allen motion; IPP Nia McKay second. Motion passed.

Motion to return to meetings every Wednesday will be addressed at a later date. The decision was also made to have leftovers of one entrée with side, salad and dessert available to members attending. There will be a charge and Colleen Martin will facilitate this.

Final item was formalizing the intent to reintroduce the OCLC Annual Golf Tournament this fall with Stan Altschuler as the chair.
