Teen Court assists youth in becoming more responsible and productive citizens.



Teen Court capitalizes on peer influence and builds skills in listening, problem solving, communication, and conflict resolution TEEN COURT IS A CHOICE, AND AN OPPORTUNITY FOR YOUTH, AGES 10-18, WHO HAVE COMMITTED AN OFFENSE THAT HAS BROUGHT THEM TO THE ATTENTION OF POLICE, SCHOOL OR JUVENILE AUTHORITIES.

- It is a rapid response to inappropriate behavior
- It provides an alternative to traditional juvenile sanctions.
- It helps youth realize accountability for unlawful actions.
- It restores self-esteem, helps youth understand the legal process and emphasizes citizen responsibility.
- Sanctions fit the offense.
- Youth understand and accept responsibility for their behavior.

Teen Court is endorsed by the U.S.

How Does It Work

- Youth are referred by area police departments, schools or others for offenses that they have admitted committing.
- ➤ They are given an opportunity to appear before Teen Court.
- Parents/Guardians and youth must attend an interview prior to the Teen Court appearance and sign agreements.
- > A date is set for the Teen Court hearing.
- ➤ Teen Court is held in an actual courtroom. There is a one-time, low court fee.
- An attorney serves as judge, while youth, who may be volunteers or former respondents, serve as jurors/officers of the court. They listen to the facts and determine an appropriate sentence.
- Sentencing is meaningful and fair. It may include community service, restitution, apology letters, essays and presentations.
- Youth are expected to serve, for a determined number of times, on a Teen Court jury.
