PETITION FOR RECALL

TO THE HONORABLE GOVERNOR RON DESANTIS:

Pursuant to the Florida Constitution, and the Florida Elections Code, we the undersigned registered and qualified voters of Lee County, respectfully state that we seek the recall and removal of Chris Patricca from the office of Member of the School District Board of Education in Lee County, Florida. The Governor shall appoint a successor.

TO SCHOOL BOARD OF LEE COUNTY DISTRICT 3 MEMBER CHRIS PATRICCA:

Pursuant to Section 100.361, Florida Elections Code, the undersigned registered qualified voters of District 3, for the School District of Lee County in the State of Florida, hereby give notice that we are the proponents of a petition for recall for your removal by the Governor, from the office of Member of the School District Board of Education in Lee County, Florida, and for the Governor to appoint your successor.

The grounds for the petition for recall are as follows: Violation of Florida State Education Statutes, Code of Ethics for Public Officers and Employees, Section 112.313(6) by using her official position as Lee County School Board Member and Florida School Boards Association President to secure special privileges and/or benefits. Violation of Florida School Boards Association Bylaws, po4140(C)(4) -Conflicts of Interest- she acted in conjunction with Andrea Messina, Executive Director, Florida School Boards Association, to attempt to manipulate the hiring process for the permanent superintendent position with the School District of Lee County. Malfeasance due to persistent repeated violations of Ethical Conduct, pursuant to School Board of Lee County Policy for School Board Member Code of Ethics and Boardsmanship, 1.05(5)(b) by her continued attempts to sabotage current Interim Superintendent, Dr. Kenneth Savage. Misfeasance, in that she speaks publicly on behalf of the board, although she's not board chair or vice-chair, going so far as to display the School District of Lee County logo behind her as she endorsed underage drinking and made racially charged remarks about the Guatemalan-American community. Malfeasance of office in that she urges the board to "vote by consensus" during workshop meetings, knowing they lack the opportunity for public input.

Chris Patricca's actions serve to make the governance Board as a whole dysfunctional, as she single-handedly disrupts the functioning of the School District of Lee County all to have control.
