

### **Play Today Waiver:**

I am agreeing to participate, or have my child participate, in activities where individuals:

1. Fire Nerf weapons at each other in an area with certain obstacles and barriers.
2. Drive Crazy Carts which are electric go-carts that can drift into corners and complete 360-degree spins.
3. Compete in games of BattleBall. BattleBall is an inflatable sphere with inner handles and adjustable shoulder straps. BattleBalls are about five feet in diameter. The objective is to score points against an opposing team similar to soccer.
4. Participate in games of Glow Dodgeball
5. Get onstage and sing karaoke songs.

Although serious injury can occur in many forms, the three greatest injury potentials associated with these activities are:

1. Eye injuries,
2. Slipping and falling,
3. Running into or Crashing into another participant or barrier.

All participants are given helmets or eye protection and are specifically instructed how to safely play each game. There are numerous signs throughout the facility specifically directing that all participants must follow approved safety procedures. Play activity is also monitored by an employee of Play Today to ensure the participants are following the written rules openly posted at the facility.

I, the undersigned participant or parent/legal guardian of a minor if the participant is under the age of 18, acknowledge and fully understand that I or the minor participant will be engaging in activities that involve risk of serious injury. I hereby agree to follow all oral instruction and written rules at all times. In the case of minor participants, I will ensure that any minor children accompanying me follow all oral instruction and written rules at all times. If I am giving consent to my minor and if I am not there, I will make sure my minor child is instructed to follow all oral instruction and written rules at all times.

Due to the COVID-19 outbreak, I affirm that I, as well as all of my household members, do not currently have, nor have experienced the symptoms associated

with COVID-19 within the past 14 days. The symptoms include: fever, fatigue, dry cough and difficulty breathing. I further affirm that I, as well as all of my household members, have not been diagnosed with COVID-19 within the past 30 days.

I understand that Play Today has taken certain measures to implement recommended guidelines and protocols issued by the Public Health Agencies for slowing the transmission of COVID-19.

I understand and agree to comply with any and all covid-19 procedures. I, for myself, and the named Participants, further acknowledge and agree that, due to the nature of the facilities, games, services and programs offered by Play Today, that social distancing of 6 feet per person is not always possible. Therefore, I, for myself, and the named Participant, understand and appreciate both the known and potential dangers of participating in Play Today activities and acknowledge that despite Play Today's reasonable efforts to mitigate such dangers, exposure and infection of COVID-19 may occur.

I, FOR MYSELF, AND THE NAMED PARTICIPANTS, HEREBY RELEASES, WAIVES DISCHARGES AND COVENANTS NOT TO SUE PLAY TODAY, ITS DIRECTORS, OFFICERS, EMPLOYEES, VOLUNTEERS AND AGENTS FOR LIABILITY RELATED TO COVID-19.

With regard to any injury occurring on the property, I hereby release and discharge Play Today from all legal liability. This release includes Play Today, its directors, officers, employees, agents, and the owners/lessors of premises used to conduct the event. Any parent signing for a minor child hereby agrees to indemnify and hold harmless Play Today, its directors, officers, employees, agents, and the owners/lessors of premises used to conduct the event from any claims by a non-signing parent/legal guardian. I agree to hold harmless and indemnify Play Today from all legal liability, claims, damages, or injury which may result from activities on the premises, including the actions of other participants. I have read this Release of Liability document and agree to its terms and conditions.
