POOL

We are still having problems with people not obeying the pool rules and the destruction of our property. When the cameras are reviewed, Joan and Terry may not always recognize these people or which house they live in.

Starting the middle of August, Electronic Card Readers are being installed on the gates to the pool. Instead of a key, you will now be using a card, similar to those used in hotels. Each swipe of your card will tell us who is entering the pool and what house the card is assigned to. Making it easier for us to identify the person or persons. These cards can be deactivated if pool rules are broken or if someone moves and takes the card with them. They can also be deactivated if your dues are not paid. Each card will be set up to only operate during certain hours eliminating the need for someone to lock and unlock the pool gates.

Each household will receive their first card free. Additional cards will be \$25.00 each. If you lose your card, all you have to do is contact Joan and she can deactivate that card, assuring that it cannot be used by anyone not authorized, then purchase a new card. In the event you fail to notify us, you will be held responsible for any damage that person may do while using your card. If a card is found, it can be read to find out who it belongs to.

Tenants will need written permission from their landlords to receive a card. Landlords will be responsible for any misuse or damage of the pool by their tenants.

Please remember that you must be with your guest at all times when they are at the pool. This is a family pool and no alcohol is allowed. Please also keep in mind that there are people living next to the pool, so keep your voices and music down. We have two day sleepers that live in close proximity and they have to be able to sleep, plus not everyone at the pool enjoys your type music.

TRASH

Please get your trash to the curb every Sunday evening for trash pick up on Monday morning. The City is now picking up trash earlier and are here by 7:00 am. When you don't take your garbage to the curb each week, and you allow it to stack up, it attracts rodents, cats, coyotes and other varmints! You can also make an enemy of your neighbor because of the odor. Please remember to bring your trash can back in on Monday evenings. Also, please, no loose trash bags! They can be easily torn into by animals.

You may request a FREE trash can by calling the City Sanitation Department. Their number is 673-6300. The City will deliver it to your home. Please put your house number on it so if it gets lost, it will find its way back to you.

Years ago when Bill Locke built Cobblestone, he built a fenced in area to accommodate the trash at each house. Now the trash cans are bigger and no longer fit. As Terry is redoing fences, he will be building an area at each house to put your trash can behind. This will keep the garbage cans out of sight. The houses that have no common ground outside their fence will need to let Terry know in which corner of their patio they want this area built.
