### APPLICATION RATES - FOLIAR SPRAY METHODS ONLY

**Apples, Pears, Melons & Peaches** - Up to 4 applications after fruit set. Apply 2 litres/ha with a minimum of 200 litres water/hectare

**Tomatoes, Strawberries & Berries, Cherries, Peppers, Potatoes** - 2 to 4 applications after fruit set. Apply 3 litres/ha with a minimum of 200 litres water/hectare.

**Grapes** - Up to 4 applications after fruit set. Apply 2 to 3 litres/ha with a minimum of 200 litres water/hectare.

**Lucerne** - 1 application at 5 to 10 cm tall at 3 litres/ha with a minimum of 200 litres water/hectare

**Home Gardener - Flower Gardens** - before flowering on leaves & during as required - mix of 1 teaspoon Formula 335 with 1 litre water

Fabulous Formula 335 has been made to provide enough negative charge to be attracted to the positive charge inside the leaf. This attraction can be made with any negative charged element. Fabulous Formula 335 contains quantities of Phosphorus that is a negative charged element whilst also being a catalyst. After application, Fabulous Formula 335 will not only enter the leaf but will become mobile within the plant.

The way Fabulous Formula 335 works centres around the explanation of how Phosphate works.

Phosphate is one of nature's catalysts and all elements should go into a plant in phosphate form with the exception of Nitrogen. The least mobile of all the elements is Calcium. The reason for this is whenever Calcium and Phosphate are mixed together they form Tri-Calcium Phosphate. The only way this compound can be made available to the plant is by microbial activity and if anything disrupts the microbial cycle in the soil, it also disrupts the uptake of Calcium and Phosphate.

The formula combines Phosphate and Calcium together in a true solution without forming Tri Calcium Phosphate and this technology does not need microbial activity to activate it.
