Phase 1

- 1) *The retainer is collected, Stephanie, our professional genealogist, email the client to ask request the Italian ancestor's information.*
- 2) *Stephanie will carry over the naturalization search and send over the info to our Italian office to procure the Italian Certificates.*
- 3) *Client will create an account to schedule an appointment with the consulate.*
- 4) *Petition for Naturalization and Italian certificates collected, eligibility confirmed, end of phase 1*
- 5) *We may ask Clients who are Eligible to begin Phase 2 while waiting for the above records.*

Phase 2

- 6) *Client send marriage, birth, death records (death only for direct lineage) to my chief genealogist, Stephanie Merlino UPS with signature required to the following address:*

- 7) *Stephanie will complete the notebook nicely organized by generations with all the certificates Apostilled and Translated along with the forms that need to be filled out before the consulate appointment (Stephanie will coach the clients on those forms) and mail it to the client.*
- 8) *Final review of the application looking for potential names discrepancies and lack of records (We can address both of those potential issues) and assistance with the consulate forms.*
- 9) *Final consultation with Dr.Domenico Meschino before the consulate appointment.*
- 10) *Client goes to the appointment and shows the documentation to the consular official.*
- 11) *Client gets approved and wait to receive a letter within weeks/months of the citizenship recognition.*
