9. Clerk's Report

Parker stated she recently submitted the quarterly payroll reports. She stated she renewed the Town's SAM's ID Registration (what is used for the ARPA funds). She stated we received notice from the State on the annual Fire Dues money.

Larson stated he has primarily been working on mowing ditches, and recently completed the first full round. He stated now he is back to brushing. He explained there was an issue with the joystick on the tractor, which has now been resolved.

Larson stated he has been watching the work on Sportsman Drive, where the lumber company that purchased the Carnes land is logging and building a road, and how they now have it posted "no trespassing".

Larson stated there has not been any more activity on Guyette Drive.

Kautza asked Larson if he did any grading today, and Larson stated he had not, but that the roads are okay yet, after the rain.

Parker asked if she can be notified when Meverden is getting ready to start the projects so that she can notify Town residents.

The Board agreed to go ahead and grant Larson the additional 60 hours of vacation, effective immediately. Parker suggested a pay raise of \$3,000 per year for the appointed clerk's position, but for it to begin January 1, 2024. The Board was fine with that. Parker will add that to the 2024 Budget.
