1. Call to Order by Chairman, Tony Kautza Chairman Kautza called the meeting to order at 6:00 p.m.

9. Review and Signing of Monthly Expenditures

The Board went through the expenditures.

Parker explained that the 18-year old who had an incident at the Dells, incurring a fire assistance charge, is slowly paying back the Town. She explained the Town received its annual 2023 recycling grant, in the amount of \$2,035.19.

10. Review and Action on 2023 Monthly Budget

Motion by McRae, second by Marien, to approve the monthly budget.

11. Clerk's Report

Parker brought up the septic system maintenance notice received by Marathon County CPZ, indicating the Town Hall's septic system (holding tank) is due for inspection, and the inspection report is due to the County within 30 days of the notice.

After some discussion, it was agreed that Kautza will contact Pecha Septic System to come out and inspect the Town's holding tank, and for Pecha to submit the report to the County.

Parker brought up there is a Marathon County Joint Eastern and Western Towns Association Meeting scheduled for Thursday, July 27th, at Memories Ballroom, in Marathon.

12. Road Report

Larson stated he had been hauling granite from Christiansen's Pit, and how this material seems to be holding up good on our roads. He stated he is now out mowing ditches, and how he has come across more tires in some ditches that he has picked up and will dispose.

Larson brought up the road damage done on Guyette Drive, by Matz's, where a logging company (Brubaker? from Colby??) had unloaded all their large equipment, causing damage to the road. Larson stated he took some pictures. There will be more follow-up on this.

13. Old Business

 Status of American Rescue Plan Act – Possible use of Funds Nothing new.

Continued Discussion on Possibly Ending County Zoning

Kautza asked the Board if they had heard anything from the County. McRae commented on the permits that were issued by the County, which we received copies of.

14. New Business

• Discussion on Creating/Updating Town Fee Schedule

Parker stated this is just for discussion and how the Town should have an official Fee Schedule. She stated this will come back next month as an ordinance.

Sippl pointed out to add the fee for special assessment letters (property searches), which we currently charge \$25.00 per parcel look-up. There was discussion how the title companies could technically look this information up themselves and how we should increase this to \$75.00, as of the 1st of the year.

There was some discussion on the hall rental fees, which currently is \$50.00 for the rental plus \$50.00 for deposit. As of the 1st of the year, we should increase these both to \$75.00.

Sippl stated the dog license fees should stay the same.

• Discussion of Making the Intersection of Pine View Road and Doolittle Drive a 3-Way Stop

Kautza stated action on this topic can be tabled for now. Parker this will ultimately be approved as an ordinance. Sippl brought up if we are looking to add additional all-way stop signs in the Town, we should look at intersections along North Pole, Sportsman, and Hatchery.

There was some discussion on the possibility to do a traffic count on Pine View Road, and seeing if we could borrow a traffic counter from the County. Marien stated he would be willing to sit out during different parts of the day, by the bridge over the Plover River, and track traffic.
