4. Presentation of Budget

Kautza pointed out that the budget was discussed at the 6:00 p.m. Town Board Meeting, which everyone in attendance was present to hear that.

Kautza explained the 2021 Tax Levy was \$286,766.00, and is now going down some to \$272,477.00.

Kautza explained the road projects that have occurred this year and what he is planning for in 2023, which may include some seal coating work, completing the other section of corduroy on Sportsman Drive, crack sealing of roads, and adding a 2nd layer of hard top on roads such as Village Road and Eau Claire River Road. He stated the Town most likely would not add any further layers onto Hatchery Road, as that road would be best reconstructed and paved. He commented on there being some spots to dig out on Hatchery Road and Crescent Drive.

Kautza stated our equipment is in good shape. He pointed out the loans that were paid off, and the offer that was given to us by Weyer's to purchase this new tractor now (versus in 2023).

Parker pointed out the Levy amount that is being proposed tonight is a "take it or leave it" amount. If the Electors vote to change anything, then we basically go through this process again next month.

Kautza asked if there were any further questions or comments, and there were none.
