Noted interest from Cllr Barry Fiske to item 6.4.1 as an adjacent neighbour.

# 5. MATTERS ARISING FOR INFORMATION ONLY:

- **5.1.** Agnes Gardner King Playground thanks to the Women's Institute (WI) who planted a Jubilee tree (flowering cherry) last week. There was a short ceremony to mark the occasion.
- **5.2.** BDC are hosting a free 90-minute webinar with Norfolk Wildlife Trust to share best practise on planting trees and hedges for biodiversity and wildlife. "Planting wilder woodlands in Broadland" Wed 9 Nov 2022 at 18:00.
- **5.3.** Norfolk County Council Budget Proposals 2023 (22 November 2022) online –proposals include an increase of 10% (which would require a referendum) and ideas for cost cutting include closing recycling centres on Wednesdays.

- **5.4.** Transport East are launching the first Rural Mobility Survey about transport in rural areas. Deadline 16<sup>th</sup> December. Agreed to meet separately to discuss the detail, along with 7.4. **ACTION CLERK**
- **5.5.** HR Clerks' appraisal has taken place and will be reviewed at the next meeting. To note that the 2022-23 pay scales have now been agreed.
- **5.6.** Caen Meadow/Malt House Lane Cllr Fiske reported on a proposal by 2 Skinners Lane to reposition their fence, taking a section of Malt House Lane. Clerk in contact with BDC on the matter and the resident is seeking advice from BA planning.
- **5.7.** Caen meadow restoration of grass on the main slope. Thanks to volunteers who came out on Tuesday to stake, rake and seed the area. Thank you to Trafford Estates for donating the grass seed for the project.
- **5.8.** Grit bins Cllr Mantle organising topping up for the winter.
- **5.9.** Keys Hill Wood Cllr Joynson need to get a quote for taking down a Sycamore which is deteriorating fast. **ACTION CLERK**
- **5.10.** Complaints from residents:
  - 5.10.1. Contact from a resident about a planning enforcement issue in Beech Road. They are already in contact with BDC over the matter. No further action.
  - 5.10.2. Speeding and wet weather on the Norwich Road making it hazardous for pedestrians. Referred to NCC and Norfolk Police.
  - 5.10.3. Speeding on The Avenue & Charles Close request for 20mph speed limit. To discuss at Finance Committee.
- **5.11.** New planning application Rivercroft Cottage, Beech Road. Remedial flood & dampness damage works, BA application no BA/2022/0386/LBC, deadline 18<sup>th</sup> November. No objection.
- **5.12.** Norfolk Minerals and Waste Local Plan Pre-Submission Extension of time period to make representations has been extended until 5pm on 19 December 2022. Review the references to Tarmac activities at Stanninghall quarry in more detail in light of item 6.2.
- **5.13.** Tree application for Hartwell House from the last meeting (item 5.8.2) Cllr Joynson visited the property and has no objection.

6.2. Water abstraction application from Norton's Broad (Wroxham) by Tarmac Trading for Stanninghall Quarry. Environment Agency application no NPS/WR/02382 (renewal). Notice was bought to the Council's application a week before the closing date. Noted recent outcome of Harris v EA at the High Court. Planning group reviewed the documentation from the EA and agreed to object. Clerk contacted the BA who would not engage on the issue. Agreed to make a complaint to BA via Cllr Fran Whymark. EA have agreed to add WPC as a consultee for future consultations. All the Bure basin licences will be reviewed as a result of the Harris case. Thanks to the resident who bought this matter to the Council's attention.

#### **Appendix 1:** Written report from Councillor Fran Whymark:

#### **Broadland District Council**

- Cllr Martin Murrell and I spoke to the Portfolio Holder responsible for food waste, Veolia are now fully aware that bins should be delivered properly in future. Any further difficulties please let us know.
- We are pleased to let you know that the Community Safety Team have been working closely with the police and Highways to make improvements to the layby on the Wroxham Rd. As many of you know nefarious activities have been ongoing for some time. Together with your local representatives we are looking how this (area avoided by local people) could be a place where families and holidaymakers wish to go in the future. Initially warning signs will be posted to dissuade persons from continuing their behaviour and car licence plates will be recorded, with Community Protection Warnings being issued in the first instance. If this is insufficient deterrent repeat offenders will be issued Community Protection Notices, any further repeat of said behaviour would lead to a fine. We are investigating if s106 or CIL monies or member grants could be used to enhance the area.
- You may have noticed social prescribers (SPs) at Hoveton and Wroxham Medical Centre? Broadland
  have been commissioned to provide SPs at all your local surgeries, offering support with unmet needs,
  particularly for the frail and elderly. Being employed through Broadland we can support patients with
  housing issues and help with concerns such as budgeting.

#### Norfolk County Council

- You will all have had emails, texts, etc. sent to you telling you how to apply for your £400 Energy Rebate? It appears to be almost daily for this or something else. Please be aware that the Government (national or local) will not contact you this way and will not ask for your bank details. NCC has regular email alerts to warn residents of scammers trying to steal your money. You can sign up at <a href="https://www.norfolk.gov.uk/business/trading-standards/scams/consumer-alerts">https://www.norfolk.gov.uk/business/trading-standards/scams/consumer-alerts</a> to receive consumer alerts to your email. You can also follow Norfolk Trading Standards on Facebook and Twitter.
- The Broadland Northway (NDR) has maintenance works currently, started Monday 31<sup>st</sup> October. There will be three weeks work at and around Wroxham Rd roundabout and then a further three weeks at the Salhouse Rd roundabout (with Highways working alongside Anglian Water to minimise disruption). This will enable sign and kerb repair and replacement, drainage works and some landscaping.
- At NCC you will be aware that we are looking at a £60 million funding gap in 2023/24. This means that we are undertaking a consultation via social media, local press and online (www.norfolk.gov.uk/budget) or you can write to: Freepost Plus RTCLXSTT-JZSK, Norfolk County Council, Ground Floor-South Wing, County Hall, Martineau Lane, Norwich, NR1 2DH; call: 0344 800 8020 or email: <a href="mailto:HaveYourSay@norfolk.gov.uk">HaveYourSay@norfolk.gov.uk</a> to request a paper copy of the consultation. Currently the options are: 1.99% Council Tax increase plus 1% for Adult Social Care (total 2.99%); 4.1% or 10.1% (i.e. inflation) but this would require a referendum. Please have your say. Consultation open until 16th December.

# **Broads Authority**

- Local anglers have won their battle to keep important spawning grounds open at Hoveton Great Broad. Natural England have now dropped plans to erect barriers to the broad, which followed the granting of a permit to do so by the Environment Agency in 2020.
- Just a reminder The BA have their Local Plan and Design Code out for consultation, which runs until 9<sup>th</sup> December.
