**Purpose:** This rental is to provide the borrower with a NeuroOptimal® system that will permit the borrower to provide NeuroOptimal® Sessions to him/herself, family and friends. The renter may share the costs and use of this equipment with another, but the person signing this contract accepts full responsibility for the safety and return of the equipment.

**Duration:** This loan is for \_\_\_\_\_. However, the lender reserves the right to request return of the equipment at any time. In such an event, the borrower will be refunded the unused number of days. If the borrower wishes to return the equipment prior to completion of the contract per weekend, there will be no refund for unused time. The borrower agrees to provide 5 business days’ notice to cancel the upcoming weekend rental. Failure to cancel 5 days in advance will result in a \$100 charge.

**Cost: \$199/weekend or \$899/month** for unlimited sessions (but no more than two sessions in a day per user). Fees are due prior to delivery. Acceptable forms of payment are cash, check (made out to Embodied Wholeness, LLC), Venmo (@Kendal-McDevitt) or Paypal ([mcdevittkb@gmail.com](mailto:mcdevittkb@gmail.com)). There is a \$100 fee per day for overdue system returns. Failure to return the equipment within 15 days following the termination of this contract will result in a \$10,000 USD charge as payment in full for the system. At this point the borrower would become a full legal owner of the license and equipment with all privileges thereto. These fees are separate and additional to the contracted rental rates above.

**Shipping** Pickup/Drop Off. Shipping (if applicable) is via FedEx. Client covers these costs.
