#### I understand that:

1. I hereby submit this application for a wastewater system and certify the above information to be factual and true to the best of my knowledge. I further certify that if the application and design plans is approved, a wastewater system Construction Permit, meeting requirements of the NEK ENVIRONMENTAL SERVICES and with all applicable laws, sanitary codes and regulations (of the county that I reside in) adopted or authorized by regulation of the Board of County Commissioners and with all applicable laws and regulations of the State of Kansas.
2. I will call NEK ENVIRONMENTAL SERVICES for a Construction and Final inspection before the system is used.
3. I will eliminate such system and make connection to a public sanitary sewer when available.
4. This permit application expires one (1) year from the date of application and is not transferable to any owner of the location for other than the applicant who signed the applicant statement. If construction of the wastewater management system has NOT been started or completed by the expiration date of the permit, a NEW permit application will need to be completed and an Application Fee will be required.

PLEASE READ AND SIGN THIS SHEET. Feel free to ask questions. NOTE: You are completing an application for a permit to operate a commercial wastewater disposal system in one of the referenced counties. When you sign this application, you agree to construct and operate the wastewater disposal system in accordance with the appropriate County Environmental Sanitary Code and Kansas Statutes or Regulations. Please understand that the application form is NOT a permit. An APPROVAL FOR CONSTRUCTION will be granted for the wastewater disposal system by the representative of NEK Environmental Services for the county as signed CONSTRUCTION PERMIT.

When completing the application, it is important that you provide the following:

1. Owner's name, mailing address and telephone number.
2. Address of location where the wastewater disposal system will be constructed.
3. Information about the water supply for the property.
4. Licensed wastewater installer's name and phone number.
5. Central Sewer available?
6. Public Water Supply/Private Well
7. Building's Use information.

READ THE APPLICANTS STATEMENT. Sign the application. Pay the fee.

NOTE: After you have completed the application, NEK Environmental Services will begin to process the application within ten (10) working days. This process includes:

1. Completion of a site evaluation of the property and soils on the property using a soil profile analysis. You will be asked to provide a backhoe and operator for completion of the soil profile.
2. A site evaluation will be provided to you including the data used to determine the type, size and location of the wastewater disposal system to be construction. A design of the proposed system shall be provided to NEKES from the licensed installer prior to permit issuance.

**NOTIFY NEK ENVIRONMENTAL SERVICES BEFORE STARTING HOUSE CONSTRUCTION.**

**Note: The licensed wastewater system installer must provide an "APPROVED AS BUILT" drawing to the company & contact showing the location and layout of the waste water disposal system. A copy of this drawing must be given to NEK Environmental Services.**
