Dave Darner brought in a proposal for the upgrading and streamlining our security systems to one company, Knight Security. 895.00 for equipment and installation fee with a monthly fee of 256.71 It will be cost efficient in the long run. Bar-Kyle Oaks is acting chairperson, he is trying to order an audit and also an inventory. Taking applications for new manager.

Campground-nothing to report.

Beach-Kyle Oaks committee chairperson is looking into rebuilding the beach house.

Boats-Dave Barker suggested that no pontoon may be used to pull or tow any other water craft or float able device.

Maintenance-Furnace in Hall and board room needed repair. Total cost was approximately 2100.00 for all repairs. Jim Arnold made a motion seconded by Mike Poeschel for the cost of necessary repair work on furnaces for the building. Pump house chlorine injector needed to be refilled with chlorine, came in at around 1000.00.

Safety- Jim Grady talked about new boat trailer for safety patrol.

Weeds- Joe Turks Will be weed committee chairperson

Shoreline- Dave Barker spoke of helping with the Coal city road project, using allocated money for it in the spring.

Fish- Phil Sheedy made a motion seconded by Mike Dunbar to reallocate funds from the fish committee to the Coal city road project for the amount of 7779.55. Vote taken -all yes, one abstained motion carried. Fish committee are putting in 20454 crappie and 20540 Walleye.
