

BASS

CHERYL-LYNN

The ongoing emergency declared in Executive Order 13873 arises from a variety of factors, including the continuing effort of foreign adversaries to steal or otherwise obtain United States classified and proprietary data. That continuing effort by foreign adversaries constitutes an unusual and extraordinary threat to the national security, foreign policy, and economy of the United States. JOYCLYN

TWO BEAT

JOYCLYN

Before that vein in your forehead explodes from frustration, obviously the new biometric & X-10 locks haven't been installed yet, we haven't uploaded your finger or retinal prints. So, until such time, I have one of these lads restricting access to anybody other than their own team or myself until after the locks are installed and activated. So, rest assured, when everything is completed, you'll have the full access you expect.

LARRY

How long before the systems are restored, and we can resume our work? It's been almost five-weeks since we've been able to conduct any further tests or [ADD BLEEPING SOUND] on the Canadian station.

JOYCLYN

It should be another seventy-two hours and your power will be restored. All the security safeguards I need in place will also be competed by that time as well. Now. . .was there something specific you wanted doctor, or can we go back to repairing your infrastructure systems rather than having a chin wag?

TARRY

[ALMOST TO HIMSELF]

The N.T.S.B are still evaluating the wreckage and going through the normal steps of their investigation, but with the pallets and canisters not there any longer, the FBI are taking a knee on this one.

BASS

The funding and resources somebody shelled out to have a team travel to the Antarctic Mountain Range, at the worst conditions of the year and get the items out. . .we're not talking street level bad guys here.

ANNE

We came to the same conclusions. Nobody on this side even imagined somebody would be brazen enough to attempt this at all, let alone in the middle of the winter season. We should have kept satellite-eyes on the area to monitor.

Chinese government?

ANNE

They're the logical first suspects; but. . .

BASS

Marshal?

ANNE

It' just. . .it's not the P.R.C. style.

Everything I've ever seen or read concerning

Beijing is always . . .overly complex. Deception,

distractions, counter measures, guile,

misdirection. According to the FBI on scene,

this was a get in, haul-out, no finesse

operation. Elbow grease & brute force. Too low
brow for Beijing.

BASS

[To himself but aloud]

So. . .then we have a new player on the board?

ANNE

Pardon?

BASS

[regains focus]

Sorry! Something; something [BEAT] Charlie always used to say.

ANNE

Good analogy, nonetheless. We have feelers out with the other US Antarctic stations and those of our allies to see if anybody noted anything unusual over the winter. With no tracks left, no indication who was on-site after rescue and little evidence to go on. . .

BASS

[CONFUSED]

Little. . .so there is some, evidence?

ANNE

Perhaps. There was an old-style pry-bar that was found. It's typical of the models sent to Amundsen or McMurdo, it stood out. The local FBI agents bagged it for evidence before they bowed out and it will be flown to Quantico to be checked for prints.

BASS

Doesn't sound like any of the tools we use down here, but I can chat with our resident engineering chief to see what he knows. Anything else you can tell me about it? Help him ID?

ANNE

Um yeah. . .where was it. . .

PAPERS SHUFFELING OVER THE PHONE

ANNE

Here we go. . .they took a snapshot with their phone, some kind of a . . .maker's stamp or hallmark on the shaft of the bar. I'll send a copy down, but it looks like. . .2130, then the letters P.L.V.M.B.O. There is what looks like maybe a star symbol and then D.E. dash 1.7.3.

SOUND OF WRITING IN NOTEBOOK

BASS

. . .got it. I'm supposed to helicopter back to McMurdo tomorrow to catch up with Special Deputy Culligan and get caught up on some reviews of staff. Our resident pilot said he could detour and put us down at the crash site for an hour to pick up personal items left behind. I could get a first-hand look at that pry-bar then.

ANNE

I'll call the lead agent on site to let them know; but I believe they may have already shipped the bar out to Quantico.

BASS

No problem if they did. Since we wanted to hit Mount Markham anyway; Mactown requested we drop off some items to the crash investigation team to

help keep them warm and safe. Propane heaters, solar chargers, fresh food vs. the emergency rations they're probably sick of by now.

ANNE

How long are you scheduled to be at McMurdo?

BASS

Only two days. Culligan wasn't briefed on the dream wax shipment and not working that case directly, so isn't aware of the operation. I'm heading down to make sure there aren't any wrinkles when our contraban or McMurdo's gets picked up and shipped out. Officially, however I'm just up there for a tour, performance evaluations and filling out paperwork.

TWO BEAT

ANNE

Any more problems with the Defense Intelligence Agent?

BASS

[SERIOUS, ANNOYED]

Oh, I have multiple problems with Joyclyn being down here. Call it muscle memory, but every time I see her in the hallways, my gun hand twitches. Everybody looking into Charlie & Janet's homicide and her alibi are telling me she wasn't in Hawaii when they were murdered.

She's well documented by more than a dozen eyewitnesses; as well as being seen on live television at the same time they died, almost half the globe away. Reluctantly . . .I have to admit. . .

ANNE

That's she's innocent.

BASS

She's far. . so far away from being anything CLOSE to innocent, but. . . its looking like she wasn't involved in the murders.

PA SYSTEM CHIME OPEN

ANNE

I'm not getting any complaints or concerns from NSF or Washington, so it sound as if things are calm, at least for the moment.

CHERYL-LYNN OVER PA

Bass darlin, Zeke needs you down in the arches. Can ya'll head down there quickly? Sounds like there may be a tusslin' going on! Thank you shug!

PA SYSTEM CHIME CLOSE

BASS

For the moment; yes. I apologize Marshal, I'm being paged.

ANNE

I heard, and it's no problem. I'm actually needed myself in another meeting. Take care deputy and let's chat when you return from McMurdo.

BASS

Yes, ma'am. Good day Marshal.

PHONE DISCONECT. SOUND OF CHAIR SLIDING BACK AND FADE OUT WITH BASS HEADING OUT

ACT V

FADE IN. WE'RE OVERHEARING EVERYTHING FROM JOYCLYN'S BODYCAM. WE HEAR BOOTS ON METAL DECKING, APPROACHING AN ARGUMENT. ZEKE IS OBVIOUSLY WORKED UP.

ZEKE

[WORKED UP]

. . .Don't care if you got orders from Yahweh himself! Ain't nobody installing nothing or connecting anything into my distribution units and inside of my power generator room unless I know what it is, and I clear it.
[TWO BEAT]

Sorry for addressing you common lord, damn fools trying to get me to loose my religion up in here.

JOYCLYN

What's the row about this time?

ZEKE

[WORKED UP]

You said all they wanted to do was set up a parallel circuit connect in my P.D.U. to get juice for whatever evil hoodoo ya'll be doing in your . . .secret squirrel room. I was hesitant, but I wanted to be a good neighbor and help out my fellow man. Now I see they trying to be installing some remote connection device on my power distribution unit.

WORKER

We tried explaining ma'am; it's simply a Fluke thirty-five-forty-three phase. . .

ZEKE

[WORKED UP]

Now just how stupid do you think I am? We use those here at the station and I know exactly what they do! I also know how you can modify them to adjust power distribution loads over the internet. Nice try lady, but not happening while I'm here!

JOYCLYN

How long you want that to be?

THREE BEAT

ZEKE

[CONFUSED]

I don't get ya.

JOYCLYN

Mister Bustamante, you're here as a contract worker, right, through the NSF.

ZEKE

[CONFUSED]

What's your point?

JOYCLYN

I'm fairly positive we can have your contract revoked for insubordination!

ZEKE

[AMUSED, GETTING MORE PISSED OFF]
Oh! Oh, you gonna threaten my job now? Threaten
me? [BEAT] Lady. . .I don't work for you; I don't
work for Beauregard-Lowing. I don't got to take
direction from any you all!

[DEEP BREATH]

But even all that said. . .you go ahead and install your little spy box. Hell, I won't stop you. I won't even move from this here spot.

THREE BEAT

JOYCLYN

[SMUG, THINK SHE'S INTIMIDATED HIM] Install it.

WE HEAR THE WORKERS FOOTSTEPS, THE CREAKING IF THE POWER PANEL OPENING, TWO SECONDS LATER THERE IS A LOUD POP AND ELECTRICAL ARCHING SOUND.

WORKER

[SCREAM IN PAIN; RECEIVED ELECTRICAL SHOCK]

JOYCLYN

[FURIOUS]

What did you do Bustamante!

ZEKE

[AMUSED]

What you mean? I've been standing right here the whole time. You was watching me with your own eyes! Just standing here, arms folded. [BEAT] DAY*UM! Looked like that was a 220 jolt what just lit you up.

JOYCLYN

You booby trapped the box?

ZEKE

Like I said, I ain't done nothing. Hand to Jesus! try any of the other PDU's if'n you want!

DOOR OPENS

JESUS

You okay Chief?

ZEKE

We still doin' this huh? Yeah, do me a solid here hey*sus! Butterfingers here just got him self a jolt. Go grab the first aid kit, one with the burn gel! They go lay hands upon him and heal.

FOOTSTEPS HEADED OFF

JOYCLYN

Fine! I'll do it. Walk me through the procedure to install.

WORKER

[minor pain]

First open the panel and find the main input connection. Should be an 8-pin set up.

CABINET DOOR OPENS AND WE HEAR A POWER DOWN SOUND

JOYCLYN

The hell, it just lost power.

CABINET DOOR CLOSES. BOOTS TO THE NEXT PANEL. THAT DOOR OPENS AND THE POWER GOES DOWN WHILE THE PREVIOUS ONE POWERS BACK UP.

JOYCLYN

[ANGERED, THROUGH CLENECHED TEETH]
Do you like playing games Bustamante, cause I know some games too!

ZEKE

I ain't doing nothing! My lady. . .on the other hand; well. . .I don't think she like you all that much.

STATION RUMBLE - LUCILLE RESPONDS

ZEKE

Calm down now Sugar! That ain't no language for a lady!

JOYCLYN

You what? You're seriously off your rocker!

STATION RUMBLE - LUCILLE RESPONDS

ZEKE

Oh, Lawman's here!

BASS' RECORDER - RECORDING STARTED DOOR OPENS BOOTS ENTER THE ROOM DOOR CLOSES

BASS

[CAUTIOUS]

Zeke? Everything alright?

ZEKE

Oh, we all peachy as pie Lawman.

BASS

Then, why is that guy on the ground holding his hand, Joyclyn at a distribution panel that's turned off and Waynewright screaming over the walkie that his and the A-1 births just had a power flicker?

ZEKE

[MATTER OF FACTLY]

Oh, that's cause these clowns tried to pull the okey doke on me and install some spy stuff in my power room.

BASS

[STILL NOT CLEAR]

Okay. That doesn't explain why . . . [HE GETS IT]

Lucille?

ZEKE

Yup!

BASS

Gotcha. They get the power they originally wanted?

TWO BOOTSTEPS FURTHER INTO THE ROOM.

ZEKE

Oh, they all good on that front.

BASS

Time to cut your losses Joyclyn.

JOYCLYN

[ANGRY]

Stay out of this Marshmellow!

CABINET DOOR CLOSES. BOOTS TO THE NEXT PANEL. THAT DOOR OPENS AND THE POWER GOES DOWN WHILE THE PREVIOUS ONE POWERS BACK UP.

BASS

You can keep on going all day with trying to install. . .whatever the hell that thing is; but unless Zeke gives his blessing; the station won't allow you or your team to do it.

CABINET DOOR CLOSES. BOOTS TO THE NEXT PANEL. THAT DOOR OPENS AND THE POWER GOES DOWN WHILE THE PREVIOUS ONE POWERS BACK UP.

ZEKE

[REMEMBERS]

Oh hey. . .what are they serving for lunch today, you find out?

BASS

Oh um. Beef stew or hot Ruben sandwiches.

ZEKE

[CLAPS HANDS , NOW HE'S HAPPY]

Rubens? HOT DAMN! Melted Swiss cheese, Russian dressing. . . I'm gonna get me TWO! Here I

thought I'd be dealing with shit all day. . . [LOUDER SO JOYCLYN CAN HERE] Excuse my language, Mary Poppins!

CABINET DOOR CLOSES. BOOTS TO THE NEXT PANEL. THAT DOOR OPENS AND THE POWER GOES DOWN WHILE THE PREVIOUS ONE POWERS BACK UP.

JOYCLYN GETS FRUSTRATED, THROWS THE METER ON THE FLOOR AND STORMS OUT.

BASS

You good here now?

ZEKE

Yeah, gonna have . . .hay-sus put some burn gel on butterfingers here and take him up to clubmed. Then, mmmmm-mmm; gonna get my Ruben on! You comin?

BASS

I'll be up in a bit. I need to chat with Franklin first.

BEGIN FADEOUT

ZEKE

You say so. . . [REDIRECT ATTENTION TO WORKER] The hell you waiting for butterfingers? Didn't you hear my boy say 'RUBENS?' Get you're crispycritter ass up and we'll go find Jesus.

ACT VI

WE FOLLOW BASS' BOOT STEPS ACROSS THE POWER ARCH, AND TO THE SPARE FUEL ROOM WHERE FRANKLIN LIVES. DOOR OPENS AND WE HEAR BASS APPROACH THE METAL TUBE. FROM INSIDE THE SOUNDS OF An OVER-PRODUCED, SACHRIN SWEET, K-POP SONG ECHOS THROUGHOUT THE ROOM.

BASS

Counselor...?

THREE BEAT

FRANKLIN

[SINGING ALONG TO SONG]

You know I'll eat you all night long I wanna taste everything you got Come on and make my tootsie pop.

BASS

[LOUDER TO BE HEARD]

FRANKLIN!

MUSIC PAUSES

FRANKLIN

Oh! I'm sorry Inspector Javert! I didn't smell you coming in.

BASS

You. . .like boy bands? You?

FRANKLIN

Pssst! Boy bands? Hardly, and by no means anywhere as embarrassing Deputy Marshal. I'm a grown demon with refined taste, after all. That was K-Pop.

BASS

The hell is 'K-Pop'?

FRANKLIN

Korean Pop Music. . .K-Pop? What all the kids listen to now-a-days, grandad!

Cute. I'd like to pick your brain on a legal matter, need somebody with court experience to help me understand.

FRANKLIN

More pro-bono work I assume? Any chance we might trade a 3-day excursion out of the tube in exchange?

BASS

Doubtful! Not sure Zeke would be amenable and all that.

FRANKLIN

Hard for Franklin to SHINE when he's stuck in this iron cylinder, but that's my cross to bear.. . wow that's a weird analogy! Okay Javert, you caught me in a good mood today. What would you like to know?

BASS

I'm conducting enhanced background checks on a few people here on station. All in relation to the crash and sabotage of the plane. Also, the station. One individual's file had. . .information which look odd to me, Items which I couldn't seem to reconcile, regarding court proceedings. So, I sent a formal request for the actual records; only to be told those were sealed and unavailable.

FRANKLIN

Court records can be a real labyrinth sometimes. What's the general information you originally received?

BASS

One of the people on station was called to testify in a criminal court matter. He wasn't being accused of anything, but the prosecution believed he would be a key-witness for the state, based upon multiple other people saying he was an eyewitness to a homicide.

He was summonsed to appear, didn't show up; had a bench-warrant issued for his arrest; contempt charges to be filed. We. . the Marshal's service were sent to pick him up; and then . . .same day were told by the D.A.'s office to stand down. Warrant was rescinded, maybe a misunderstanding or something. . .don't know.

When I requested the court documents on why the bench-warrant was called off and to see what happened; I was told those documents were sealed and not available by order of the chief magistrate.

FRANKLIN

Court documents can be sealed for various reasons, typically to protect sensitive information or individuals involved. It could be anything from witness safety to the privacy of individuals involved in the case. If there is a court seal in place; there should be a listing of who ordered it and their court.

BASS

Um. . . I did see that, hang on a second. . .

PAPERS FLIPPING

BASS

Ordered by my hand, 12-November-2002. The Honorable Shamus O'Halloran; United States District Court for the District of Massachusetts.

FRANKLIN

[IRISH IMPRESSION]

Sure'n, there be nary a more Irish name in all the city of Boston; east of blackrock.

PAPERS FLIPPING

BASS

[HALF PAYING ATTENTION]

Yeah, don't do that. . . I seriously want to know more about why this guy was cut lose so quickly; but without having this unsealed. . .

FRANKLIN

[SHIFT TO DEMON]

Hrm. Tell me more about the murder case.

BASS

Pretty straight forward. Two in the morning. Small handful of people in a dive bar in South Boston called Shannon Tavern. One guys said something the other didn't like. Started with pushing, then fists were thrown, and ended when one guy took a broken beer bottle to the throat.

FRANKLIN

[DEMON]

[SIGH] Only YOU could make something as delicious as murder taste so. . .blah, bland. Uh, who was the stab-ee? A cop, a politician, some elected official?

BASS

Um. . no, nothing like that. He was a dock worker from what I remember.

FRANKLIN

[DEMON, CONFUSED]

What? That doesn't make sense. Was anybody else killed, or seriously hurt by the accused murderer?

BASS

Not. . .no, other than a woman who tripped on a bar stool trying to get out of the way, nobody else was hurt that night?

FRANKLIN

[DEMON, TRYING TO MAKE SENSE OF THIS] Okay. . but when he was arrested, he fought the officers and one of them was hurt? Badly?

BASS

Nope. When they found the murderer, he was so drunk they were able to take him in and get him processed with no hassle. Guy shit his pants, literally. . .but other than that; nothing.

FRANKLIN

[DEMON, EVEN MORE CONFUSED]

That. . .something really is off. Flip to the front of the document to recall the Bench Warrant. It might be called Motion to Quash Warrant. What's the name of the presiding judge and their court?

BASS

Um. . .

PAPERS FLIPPING

BASS

Same judge as who had the documents sealed.
... Shamus O'Halloran, United States District
Court for the District of Massachusetts.

FRANKLIN [HUMAN]

Whose court was the Murder trial being heard in?

BASS

It was Court Room 7 Case number 0203CR001026 Commonwealth of Massachusetts, Superior Court. Hon. Jennifer L. Ginsburg

FRANKLIN [HUMAN VOICE]

So, a Federal Court Judge, ordered documents sealed on a case being heard at the state level. Wait. . .you said the Marshal's service were given the bench Warrant? For a state level offense? Who signed that?

BASS

Yeah. . .that's another weird thing. The signature and printer name has been redacted.

FRANKLIN [HUMAN VOICE]

You have something I've never seen in all my time! A federal judge typically doesn't have authority to seal documents in a state court case. State courts and federal courts are separate and distinct systems with their own sets of rules and procedures.

In a state court case, the judge presiding over that case is responsible for making decisions regarding the sealing or unsealing of documents. Federal judges have jurisdiction over cases that fall under federal law or involve federal parties, and they do not have authority over state court proceedings.

In theory. . .its possible a federal judge's order or decision could impact a state court case indirectly, but this isn't anything I've heard of before.

BASS

Any instances where it would have been remotely possible?

FRANKLIN

[CONSIDERING]

It would have to be an extreme instances. Potential harm to a massive intellectual property, maybe. Risk of direct potential harm to a high-ranking government official. . .or risk of breaching sensitive or highly classifi [SNIFF, SNIFF]

BASS

What?

FRANKLIN

[DEMON]

Wow! Haven't smelled that in a while! And never so pungent!

BASS

Smell, what exactly?

FRANKLIN

[DEMON]

The veil has been pierced, [SNIFF] and close by Too! Normally the smell only carries 50-yards or so. [SNIFF-SNIFF] Yep! That smell is absolutely from purgatory or could be from St. Louis. They smell the same. Frightening place Missouri! Smells like a death Omen is moving about.

YELLS FROM FRIGHTEND MEN AND RUNNING FROM THE HALLWAY.

BASS

Thanks for the help, Franklin! I need to see what that's all about.

FRANKLIN

Always happy to help.

K-POP TURNED BACK ON AS BASS LEAVES THE ROOM AND ENTERS THE HALLWAY. DOOR SHUTTING BEIND HIM. THE ECHOING SOUND OF FLEEING FOOTSTEPS NOW DISTANT, WE HEAR ZEKE APPROACHING, ODDLY CALM.

ZEKE

Oh hey, happy to see you still around. You want to go tare up some Rubens?

BASS

[CONFUSED]

Zeke? The hell just happened down here. Why did all special staff Beau-low bring in to repair the breaks just take off running and screaming?

ZEKE

Oh that. . .yeah! So, I'm helping my boy Jes. . .Hay-sus get the one worker who got zapped back to his feet, put an ice pack on his hand and ask . . .my boy to take him up to medical for me.

They take off, I radio into my team, you know. . making sure they all set to be okay for an hour or so, and somebody keeps there eye on Keenan. Anyhow, back in comes Joyclyn with some other of her workers, she tells to wrap up with the connections and forget the monitor. That's when the lights inside start flickering and. .

.whoosh. Doctor Rodney's appeared. Damned Beaker looking all pale and bloody from his murder and what not, and he says that thing you said he said back on your birthday. [Spooky voice] 'I may be the first, but not the last!' Pointing his boney ghost finger at the workers and fading in and out.

That's when they panicked and ran!

BASS

Zeke? You okay? You hate scarry stuff. When we all gathered to watch the Shining at the start of Winter, you left in a hurry!

ZEKE

Oh, I still won't be watching that anytime soon. And not just for the scarry stuff neither, but for how Kubrick did ScatMan Crothers dirty like that! My man flies 15 states on a plane, through a blizzard, hops on a snowcat for another six hours and gets an axe as soon as he steps foot inside? That shit messed up. R.I.P. Scatman!

BASS

[CONFOUNDED]

A ghost on the screen terrifies you, but one pops up in front of you in-person and you're all cool?

ZEKE

[CLARIFYS]

A. I'm cautious, not terrified! Best check yourself there lawman! B. Punk-ass beaker didn't intimidate me in the least when he was takin' in air. I'll be damned if his necro-American, seethrough ass gonna change that. C. .It's RUBEN day man! Nothing, and I mean ab-so-lute-ly NOTHING gets in the way of me getting my Ruben on!

BASS

You are a strange and complex man Zeke Bustamante!

THE SOUND OF HEELS APPROACHES SLOWLY. JOYCLYN APPEARS, FROM AROUND THE CORNER

JOYCLYN

[MILD SHOCK]

That . . . that was a ghost. That was an honest, according to Hoyle . . . ghost I just saw. [THREE BEAT] What the hell is going on down here Marshmellow?

FOOTSTEPS WALKING DOWN THE HALL

BASS

[FROM A DISTANCE, ON JOYC'S RECORDER] It's not something in the water. . .I checked!
