The Council of the City of Brundidge, Alabama met in regular session Tuesday, June 6th, 2023 at 6:00 o'clock p.m. at City Hall at which time and place the following members were present: Holland, Hall, Ross, Gaynor, and Rodgers. Absent: Boyd. Mayor Pro Tem Gaynor called the meeting to order.

The minutes for the May 16th, 2023 council meeting was presented and upon a motion by Mrs. Rodgers second by Mrs. Hall, with all voting yea, the minutes were approved as presented.

Mayor Pro Tem Gaynor opened the meeting with a public hearing regarding the submission of an application for the Program Year 2023 Community Development Block Grant (CDBG). Ashton Hutchison from South Central Development Commission presented the ones in attendance with the options available for the City to apply. She said the City is focusing on major infrastructure improvements to the waste/water treatment plant. Partnering with funds from ADEM and CDBG Economic Development Funds it is the City's' desire to completely rehab the waste/water treatment plant along with some lift stations. Mrs. Hutchison opened the floor for discussions or questions and there being none the public hearing was closed.

Mr. Wright advised the council there has not been a rate study performed for the electric and water/sewer departments since 2009. To ensure the City is financially stable to cover the increase in costs and to cover future needs in these departments, a rate study is crucial to have completed. Mrs. Rodgers moved the council approve the rate study performed by Poly for the water/sewer rates at a cost of \$17,710.21 and to engage Jackson-Thornton to perform the electric rate study for \$19,000. Mrs. Ross seconded the motion and with all voting yea the motion carried.

There being no further business to come before the council, Mr. Holland moved the meeting to be adjourned with a second by Mrs. Rodgers.
